(Under Section 251 of the General Corporation Law of the State of Delaware)

Linedata Lending and Leasing Inc., a corporation incorporated and existing under and by virtue of the General Corporation Law of the State of Delaware, does hereby certify:

FIRST: The name and state of incorporation of each of the constituent corporations which are to merge are as follows:

LD Services, Inc.	Delaware

SECOND: That an Agreement and Plan of Merger, dated as of July 1st, 2018, by and between Linedata Lending and Leasing Inc., a Delaware corporation, and LD Services, Inc., a Delaware corporation (the "**Agreement and Plan of Merger**"), has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations of the merger.

THIRD: That pursuant to the Agreement and Plan of Merger, LD Services, Inc. will merge with and into Linedata Lending and Leasing Inc., with Linedata Lending and Leasing Inc. as the surviving corporation of the merger (the "**Surviving Corporation**"). The Surviving Corporation will change its name "Linedata Asset Management Inc." The Surviving Corporation is a Delaware corporation.

FOURTH: The Certificate of Incorporation of Linedata Lending and Leasing Inc. as in effect immediately prior to the merger shall be the Certificate of Incorporation of the Surviving Corporation and the Article thereof numbered "FIRST" is hereby amended to read as follows:

"The name of the corporation is Linedata Asset Management Inc. (the "Corporation")."

FIFTH: That the executed Agreement and Plan of Merger is on file at the principal place of business of the Surviving Corporation at 1111 3rd Ave – Suite 950 – Seattle, WA 98101 - USA.


