RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this “Release”) is made as of November 28, 2023 (“Effective Date”) by FORTRESS CREDIT CORP., as collateral agent for the Secured Parties (in such capacity, together with its successors and permitted assigns, “Collateral Agent”) in favor of GRINDR LLC (“Grantor”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement or the Trademark Security Agreement (each as defined below), as applicable.

WITNESSETH:

WHEREAS, pursuant to that certain Security Pledge Agreement, dated as of June 10, 2020 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), among the Grantor, the other grantors from time to time party thereto and the Collateral Agent, the Grantor entered into that certain Grant of Security Interest in Trademark Rights, dated as of April 14, 2023, in favor of the Collateral Agent (the “Trademark Security Agreement”), pursuant to which the Grantor granted to the Collateral Agent a continuing security interest in, to and under all Trademark Collateral, including without limitation the Trademarks listed on Schedule A hereto;

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office (“USPTO”) on April 19, 2023 at Reel 8046 and Frame 0653; and

WHEREAS, the Grantor has paid in full all of the obligations that are secured by the Trademark Collateral and has requested that the Collateral Agent terminate and release the entirety of its security interest in the Trademark Collateral.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Collateral Agent hereby (i) terminates, cancels, releases, and discharges the Security Agreement, the Trademark Security Agreement, and its continuing security interest in, to and under the Trademark Collateral, including without limitation the Trademarks listed on Schedule A hereto, and (ii) reassigns, grants and conveys to the Grantor any and all of Collateral Agent’s right, title and interest in, to and under the Trademark Collateral, in each case of (i) and (ii), without recourse, representation, or warranty.
2. The Collateral Agent authorizes the recordation of this Release with the USPTO.
3. This Release shall be governed by, and construed in accordance with, the law of the State of New York.
