NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby acknowledges that it assigned to Assignee all right, title, and interest in and to the ENZEEVU MARK, all causes in action (including the right to bring suit for past infringement of the ENZEEVU MARK), the right to file applications for and secure registrations thereof and to renew, extend, maintain, abandon or otherwise control any ENZEEVU MARK and associated applications, registrations and renewals, reissues, and extensions thereof in the United States of America, together with the good will of the business symbolized by the ENZEEVU MARK, that portion of the business associated with the ENZEEVU MARK, and any applications and registrations therefor, the same to be held and enjoyed by the said Assignee, its successors and assigns, from and after Effective Date as fully and entirely as the same would have been held and enjoyed by the said Assignor had this Assignment not been made, and all common law rights in the ENZEEVU MARK.

WHEREAS, it is desired that this Assignment be made of record in the U.S. Patent and Trademark Office.
