**RELEASE OF TRADEMARK SECURITY  
AGREEMENT**

This RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of December 18, 2023 (the “Release”), is made by ACQUIOM AGENCY SERVICES LLC, as administrative agent (in such capacity, the “Administrative Agent”), in favor of AMERICA’S TEST KITCHEN LIMITED PARTNERSHIP in its capacity as Grantor (as defined below), in connection with the termination of that certain Trademark Security Agreement (the “Trademark Security Agreement”) dated as of February 2, 2023 made by America’s Test Kitchen Limited Partnership (the “Grantor”) in favor of the Administrative Agent. Capitalized terms not defined herein shall have the meaning ascribed to them in the Trademark Security Agreement.

**W I T N E S S E T H**

WHEREAS, pursuant to the Trademark Security Agreement, which was recorded with the U.S. Patent and Trademark Office on February 2, 2023 at Reel 7959/Frame 0608, the Grantor granted the Administrative Agent a security interest in the Trademark Collateral (as such term is defined in the Trademark Security Agreement), including the Trademarks listed in Schedule I hereto (the “Trademark Collateral”);

WHEREAS, the Grantor has requested that the Administrative Agent enter into this Release in connection with the termination of the Trademark Security Agreement.

NOW, THEREFORE, in consideration of the foregoing, the Administrative Agent, without recourse to or representation or warranty by the Administrative Agent of any kind, hereby (i) releases all of its security interests and liens in and to the Trademark Collateral, including without limitation the Trademark Collateral listed on Schedule I attached hereto and incorporated herein by reference, (ii) terminates the Trademark Security Agreement, and (iii) if and to the extent the Administrative Agent has acquired any right, title or interest in, to or under the Trademark Collateral, re-assigns to the Grantor any right, title and interest it or they have in, to and under the Trademark Collateral.

This Release shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.


