RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (“Release”) is made effective as of December 18, 2023 by PATHLIGHT CAPITAL LP, as Agent whose address is 100 Federal Street, 20th Floor, Boston, MA 02110 (the “Secured Party”), to CONN’S, INC., a Delaware corporation, whose address is 2445 Technology Forest Blvd., Suite 800, The Woodlands, Texas 77381 (the “Grantor”), as follows:

WHEREAS, on February 21, 2023, the Grantor, the other grantors party thereto, and the Secured Party entered into a Security Agreement (as amended from time to time, the “Security Agreement”);

WHEREAS, on February 21, 2023, the Grantor and the Secured Party entered into a Memorandum and Notice of Security Interest in Intellectual Property (the “Memorandum and Notice”);

WHEREAS, pursuant to said Security Agreement and Memorandum and Notice, the Grantor granted to the Secured Party, among other collateral set forth therein, a security interest in and to all of the Grantor’s right, title and interest in and to the trademark registrations and applications therefor which are identified on Exhibit A attached hereto and herein incorporated by this reference owned by Grantor (the “Trademarks”), together with the goodwill and assets of the business, to which such Trademarks are appurtenant and all actions for infringement concerning the foregoing;

WHEREAS, said Memorandum and Notice was recorded in the United States Patent & Trademark Office on February 22, 2023, at Reel/Frame 7982/0669; and

WHEREAS, the Secured Party now wishes to terminate and release the Memorandum and Notice and the entirety of its security interest in and to the Trademarks.


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Secured Party without recourse, representation or warranty and at the Grantor’s sole cost and expense, hereby: (i) terminates the Memorandum and Notice, (ii) terminates, cancels, releases, relinquishes and discharges, in its entirety, for the benefit of the Grantor, and their successors and assigns, its security interest in and to the Trademarks, and (iii) assigns, grants and conveys to the Grantor any and all of the Secured Party’s right, title and interest in and to the Trademarks. The Secured Party hereby authorizes the Grantor and its successors, assigns or other legal representatives to file this Release with the United States Patent and Trademark Office, at the sole expense of the Grantor, to evidence and effectuate the release and termination of the Secured Party’s security interest in the Trademarks. The Secured Party further authorizes and requests that the Commissioner for Trademarks of the U.S. Patent and Trademark Office record this Release.


