Release of Security Interest in Trademarks

This Release of Security Interest in Trademarks, dated as of **February 10, 2021** (the "Release"), is made by **Credit Suisse AG, Cayman Island Branch**, as collateral agent (in such capacity, the "Agent") in favor of **P.D.R. Solutions (U.S.) LLC**, a **Delaware limited liability company** (the "Grantor").

WHEREAS, by (i) that certain Third Amended and Restated Credit Agreement, dated as of **November 25, 2013** in favor of Agent (as amended, restated, or modified from time to time, the "Credit Agreement") and (ii) that certain related Trademark Security Agreement, dated as of **March 26, 2019** in favor of Agent (as amended, restated, or modified from time to time, the "Trademark Security Agreement"; capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Credit Agreement or Trademark Security Agreement, as applicable), which Trademark Security Agreement was recorded with the United States Patent and Trademark Office on **March 28, 2019** at Reel **006602** Frame **0965**, the Grantor granted to Agent, for the benefit of the Secured Parties, a lien on and security interest in all of the Grantor's right, title and interest in, to and under the Collateral (as defined in the Trademark Security Agreement), including those Trademarks listed on Schedule I hereto;

WHEREAS, the Grantor desires the Agent to release, discharge, terminate and cancel its lien on and security interest in the Collateral of the Grantor (as defined in the Trademark Security Agreement), including, without limitation, the Trademarks set forth on Schedule I hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of the Secured Parties, does hereby release, discharge, terminate and cancel any and all of its right, title and interest in and to the Collateral of the Grantor (as defined in the Trademark Security Agreement), including any and all goodwill relating to the same, and assigns, transfers and conveys to Grantor any and all of its rights, title and interests in the Collateral.

The Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.


