AFFIDAVIT

I, Roberta L. Christensen, declare under penalty of perjury as follows:

1. I am over the age of eighteen and competent to make this Affidavit.
2. The facts stated in this Affidavit are within my personal knowledge and are true.
3. I am the attorney of record for the current owner and correct owner of the above-referenced trademark ("Mark") and am authorized to make this Affidavit on both entities' behalf.
4. On November 7, 2012, an Amalgamation Assignment was recorded at Reel/Frame 5237/0659. The Amalgamation, effective November 7, 2012, was between Carex Health Brands Canada Inc. (a Canadian Corporation) ("Carex") and Uplift Technologies, Inc. (a Canadian Corporation) ("Uplift"). Carex and Uplift were amalgamated as one company under the name Carex. Please see Exhibit A.
5. On October 19, 2016, an Assignment assigning the entire interest and the goodwill was recorded at Reel/Frame 5904/0138. The Assignment, effective October 17, 2016, assigned the entire interest and the goodwill from Uplift to Compass Health Brands Corp. ("Compass").
6. The Assignment at Reel/Frame 5904/0138 is erroneous because the owner of the Mark as of October 17, 2016 was Carex, not Uplift. Uplift lacked the necessary ownership in the Mark to assign it to Compass. Accordingly, the last correct owner, Carex, continues to be the owner of the Mark, not Compass Health Brands Corp.
7. I declare that, to the best of my knowledge and belief, the information herein is true and complete. I understand this statement is made for use as evidence in court and is subject to penalty for perjury.

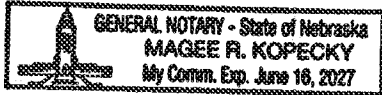
