TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT (this "**Agreement**") dated as of September 29, 2023 is made by DE PERE CABINET, INC., a Wisconsin corporation with an address of 1745 East Matthew Drive, De Pere, Wisconsin 54115, HCI WELLBORN FOREST HOLDINGS, LLC, a Delaware limited liability company ("**Parent**") with an address of 2212 Airport Blvd., Alexander City, Alabama 35010, and WOODHARBOR MOLDING & MILLWORKS, LLC, a Delaware limited liability company with an address of 3277 9th Street SW Mason City, Iowa 50401 (together with each of their successors and assigns, "**Grantors**"), in favor of MANUFACTURERS AND TRADERS TRUST COMPANY, a New York banking corporation with an address of One Light Street, 13th Floor, Baltimore, Maryland 21202 in its capacity as Administrative Agent (together with its successors and assigns, in such capacity, "**Administrative Agent**").

WHEREAS, this Agreement has been executed by Grantors for the purpose of recording the grant of security interest herein and in the Security Agreement (as defined below) with the United States Patent and Trademark Office;

WHEREAS, Grantors are the owners of certain trademarks, including the applications and registrations thereof, and the trade name and common law rights thereto, together with the goodwill of the business connected with the use of and symbolized by the trademarks, including that portion of the business to which the trademarks pertain, and all proceeds thereof, including, without limitation, any and all past, present and future causes of action which may exist by reason of infringement thereof, set forth on Schedule A hereto (collectively, the "**Trademarks**");

WHEREAS, Parent and HCI Wellborn Forest Buyer, Inc., a Delaware corporation (the "**Borrower**"), entered into that certain Credit Agreement, dated as of the date hereof (as amended, restated, modified and/or supplemented, from time to time, the "**Credit Agreement**"), with the Lenders (as defined therein) and Manufacturers and Traders Trust Company, as the Issuing Bank, a Lender, the Swingline Lender and the Administrative Agent (in each case as defined therein), pursuant to which the Lenders agreed to extend credit to the Borrower on the terms and conditions described therein; and


WHEREAS, in connection with the Credit Agreement, Grantors entered into that certain Security Agreement dated as of the date hereof (as amended, restated, modified and/or supplemented, from time to time, the "**Security Agreement**"), in favor of Administrative Agent, pursuant to which Grantors granted to Administrative Agent a security interest in all right, title and interest of such Grantors in and to, among other things, the Trademarks to secure the payment, performance and observance of the Secured Obligations, as defined in the Credit Agreement.

NOW, THEREFORE, for good and valuable consideration, Grantors hereby pledge and grant to Administrative Agent (and confirm and ratify all other pledges and grants heretofore made to Administrative Agent) a security interest and lien in and to the Trademarks, subject to the terms and conditions of the Security Agreement and Credit Agreement, which are hereby incorporated by reference as if fully set forth herein.


