RELEASE OF SECURITY INTEREST AND REASSIGNMENT OF TRADEMARKS

October 31, 2022

Reference is hereby made to that certain Third Lien Intellectual Property Security Agreement, dated as of June 24, 2021 (the "Security Agreement"), executed by U.S. Well Services, LLC (the "Company") whose address is 1360 Post Oak Boulevard, Suite 1800, Houston, TX 77056 in favor of Wilmington Savings Fund Society, FSB, as collateral agent (together with its successors in such capacity ("Notes Agent") whose address 500 Delaware Avenue, 11th Floor, Wilmington, DE 19801. The Security Agreement was recorded with the Assignment Recordation Branch of the U.S. Patent and Trademark Office on June 29, 2021, at Reel 7339, Frame 0087, pursuant to which the Company mortgaged, pledged and granted to the Notes Agent, for the benefit of the Secured Parties (as defined in the Security Agreement), a continuing security interest in, and lien on, the Company's IP Collateral (as defined in the Security Agreement), including the trademarks specifically listed on Schedule 1 attached hereto and the goodwill associated therewith;


WHEREAS, the Obligations (as defined in the Security Agreement) have been paid in full and Notes Agent wishes to terminate the Security Agreement, release said security interest in, and lien on, all of the Company's IP Collateral, and retransfer and reassign to the Company, without representation or warranty, all of Notes Agent's right, title and interest in and to the IP Collateral and the goodwill associated therewith;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Notes Agent hereby (i) terminates the Security Agreement, (ii) releases said security interest in and to the IP Collateral, (iii) cancels, releases, terminates and discharges any and all of its right, title and interest in the IP Collateral, and (iv) transfers (or retransfers) and assigns (or reassigns) to the Company, without representation or warranty, all of Notes Agent's right, title and interest in and to the IP Collateral together with the goodwill associated therewith.
