As used herein, the term "Trademark Collateral" means (i) the trademarks and trademark applications listed on Schedule I hereto, (ii) all renewals thereof, (iii) all income, royalties, damages and payments now and hereafter due and/or payable under and with respect thereto, including without limitation, damages and payments for past or future infringements thereof, (iv) the right to sue for past, present and future infringements thereof, (v) all rights corresponding thereto throughout the world, (vi) all goodwill of the Grantor's business connected with and symbolized by such trademarks and (vii) the rights granted to Agent with respect to such trademarks and trademark applications pursuant to the (x) 2016 Security Agreement as recorded on behalf of Agent by the United States Patent and Trademark Office on October 11, 2016, at Reel/Frame 5897/0683 in the United States Patent and Trademark Office and (y) 2019 Security Agreement as recorded on behalf of Agent by the United States Patent and Trademark Office on June 17, 2019, at Reel/Frame 6671/0072 in the United States Patent and Trademark Office.
