- First:** The name of the corporation is ABBYY INC. (the “Corporation”).
- Second:** The Corporation’s registered office in the State of Delaware is located at: 874 Walker Road, Suite C, Dover, DE 19904, Kent County. The name of its registered agent at such address is United Corporate Services, Inc.
- Third:** The purpose of the Corporation is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of Delaware (the “DGCL”).
- Fourth:** The total number of shares of capital stock the Corporation is authorized to issue is Eleven Million (11,000,000) shares with a par value of \$.01 per share.
