**TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this "Termination"), dated as of November 22, 2023, and made by **WESTERN ALLIANCE BANK**, an Arizona corporation ("Lender"), to **FLEETWORTHY SOLUTIONS, INC.**, a Wisconsin corporation ("Grantor").

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of November 24, 2021, made by Grantor in favor of Lender (the "Security Agreement"), a security interest was granted by Grantor to Lender in the Intellectual Property Collateral (as defined in the Security Agreement), including the Trademarks (as defined in the Security Agreement) set forth in Schedule A hereto;

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on December 7, 2021 at Reel/Frame 7523/0157;

WHEREAS, Lender now desires to terminate the Security Agreement and terminate, release and discharge its security interest in the Intellectual Property Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Lender hereby acknowledges and agrees as follows:

1. Release of Security Interest. Lender hereby terminates the Security Agreement and absolutely, unconditionally and irrevocably terminates, releases, cancels and discharges all collateral pledges, grants, liens and security interests granted by Grantor in favor of Lender in and to the Intellectual Property Collateral and all rights, title and interests in, to and under the Intellectual Property Collateral.

2. Recordation of Release. This Termination may be recorded by Grantor, or its successors or assigns, with the United States Patent and Trademark Office.

3. Governing Law. This Termination shall be governed by, and construed and enforced in accordance with, the laws of the State of California, excluding conflict of laws principles that would cause the application of laws of any other jurisdiction.
