## CONFIRMATORY TRADEMARK ASSIGNMENT

This Assignment Agreement, dated as of May 30<sup>th</sup>, 2019 (the "Agreement"), is made by and between Valeant Pharmaceuticals Luxembourg Sarl, having its registered office at 9 Allee Scheffer, 2520 Luxembourg, Grand-Duchy of Luxembourg ("Assignor") and Bausch Health Ireland Limited, a company established and existing under the laws of Ireland having its registered office at 3013 Lake Drive, Citywest Business Campus, Dublin 24, Ireland ("Assignee").

**WHEREAS**, as a result of a sale and purchase transaction dated January 23<sup>rd</sup>, 2017, Assignee is now the owner of all rights, title and interest in and to the registrations set forth on **Schedule A** (collectively, the "Trademarks"); and

**NOW, THEREFORE**, in consideration of the mutual promises set forth in this Agreement and for other good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereby agree as follows:

1. Assignment of Trademarks. Assignor does hereby confirm that it has sold, conveyed, assigned, and transferred to Assignee all of Assignor's right, title and interest in and to (i) the Trademarks, together with the goodwill symbolized thereby, and (ii) all benefits, privileges, causes of action, common law rights, and remedies relating thereto throughout the world, including, without limitation, all of Assignor's rights to (a) apply for and maintain all registrations, renewals and/or extensions thereof, (b) bring actions and recover damages for past, present and future infringement or other violation thereof, and (c) grant licenses or other interests therein.
2. Successors and Assigns. This Agreement and all of its provisions shall be binding upon and inure to the benefit of the parties hereto and their respective permitted successors and assigns.
3. Governing Law; Jurisdiction. This Agreement shall be governed in all respects by the laws of the State of New York, without giving effect to the principles of conflicts of law thereof.
4. Counterparts. This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, but both of which together shall constitute one and the same instrument.
