There appeared:

STEFANO LANDI, born in Reggio Emilia on 30 June 1958, domiciled for the present purposes at the registered office address of the company named below, participating in the present act in his capacity as Chair of the Board of Directors of the company:

"LANDI RENZO S.P.A." with a registered office address at Via Nobel No 2/4, Cavriago, paid up share capital EUR 11,250,000, Reggio Emilia Companies' Reg. No and TIN 00523300358, suitably authorised for the present purposes by the Board of Directors of the said company by resolution dated 20 October 2017 as detailed in the following, and in implementation and performance of the contents of the resolution;

CRISTIANO MUSI, born in Parma on 27 April 1974, domiciled for the present purposes at the registered office

S.p.A." with a registered office address at Via dell'Industria 20, Cavriago, paid up share capital EUR 2,800,000, Reggio Emilia Companies' Reg. No and TIN 01160540355, suitably authorised for the present purposes by resolution of the Extraordinary Shareholders' Meeting of the said company dated 20 October 2017 as detailed in the following, and in implementation and performance of the contents of the resolution;

I the Notary have satisfied myself as to the identity of the persons appearing, who in accordance with the law and with my consent have dispensed with the formality of having this act witnessed.

WHEREAS

- the company "LANDI RENZO S.P.A." with a registered office address at Via Nobel No 2/4, Cavriago, by resolution of the Board of Directors dated 20 October 2017 certified by myself on the same date under Protocol No 17,095/10,822, registered in Reggio Emilia on 26 October 2017 under No 14772 and entered into the Reggio Emilia Companies' Register on 20 October 2017, decided to merge with the company "A.E.B. S.p.A." by absorption of the latter, based on the details of the statement of financial position as of 30 June 2017 of the absorbed company and the half-yearly financial statement to 30 June 2017 (replacing the statement of financial position) of the absorbing company, both drafted in accordance with Article 2501-*quater* of the Civil Code;

- the said company "A.E.B. S.p.A." by resolution of the Extraordinary Shareholders' Meeting of the said company dated 20 October 2017 and relevant minutes certified by myself, Protocol No 17,094/10,8271, registered in Reggio

Emilia on 26 October 2017 under No 14771, decided to merge with the above-mentioned company "LANDI RENZO S.P.A." by absorption into the latter, based on the details of the statement of financial position and the half-yearly financial statement of the respective companies as detailed above;

- in view of the fact - as confirmed by the representatives of the said companies, who assume full legal responsibility for their statements – that no court or out-of-court challenges have been filed to the operation resolved on and that the legal waiting periods have elapsed;

NOW THEREFORE,

the recitals being considered an integral and substantive part of the present act, it is agreed as follows.

1) In performance of the relevant resolutions of the Board of Directors and the Shareholders' Meeting of the said companies and by virtue of the present act, the company "A.E.B. S.p.A." is merged, with full and final effect, by absorption into the company "LANDI RENZO S.P.A."

As a result of the said merger and in accordance with Article 2504-bis of the Italian Civil Code, the absorbing company assumes all of the rights and obligations of any nature whatsoever of the absorbed company and fully succeeds in all its property, as well as in all its assets and liabilities of any nature and type whatsoever.

2) The merger by absorption under the present act is performed based on the details of the statement of financial position and the financial statement of the respective companies as mentioned in the resolutions by the companies themselves and recorded in the minutes certified by myself the Notary as mentioned in the recitals, which are hereby expressly referred to in accordance with the applicable laws.

3) As a result of the merger in accordance with the foregoing, the above-mentioned resolutions of the companies "LANDI

RENZO S.P.A." and "A.E.B. S.p.A." hereby take full effect, the persons appearing acknowledging that the absorbing company "LANDI RENZO S.P.A." has acquired and retains ownership and possession of the all of the shares constituting the entire share capital of the company "A.E.B. S.p.A A.", the merger being concluded without any capital increase on the part of "LANDI RENZO S.P.A." and by cancellation without exchange of the shares constituting the share capital of the company "A.E.B. S.p.A A."

4) As a result of the merger by absorption under the present act, all company officers of the absorbed company are removed from office with full legal effect from the present date, and all powers of attorney issued by the company and its governing bodies are likewise terminated.

5) Any public and/or private body, entity or office with ongoing business with the absorbed company is hereby authorised to continue the said business with the absorbing company, amending all relevant all acts and documents to place them in the latter's name and settling all payables with the latter, any officials involved in the necessary formalities being fully indemnified and held harmless.

6) The persons appearing, again acting in their stated capacities, grant all relevant powers so that the Authorities appointed to manage Public Registers containing entries for property and/or property rights and/or title in the name of the absorbed company can make the relevant annotations in their registers and records concerning the merger under the present act and its effects on the said property and/or rights, indemnifying and holding harmless any officials involved in the necessary formalities.

To this end, the persons appearing declare that the absorbed company holds the following assets:

A) The vehicles included in the list annexed to the present act under letter "A", the parties having expressly instructed me to dispense with the formality of reading the said annex; the Public Automobile Registrar is hereby authorised to perform all of the necessary formalities, being indemnified and held harmless from any relevant liability.

B) The trademarks, patents and designs included in the list annexed to the present act under letter "B", the parties having expressly instructed me to dispense with the formality of reading the said annex.

C) The 96 per cent shareholding in the share capital of the company "AEB AMERICA S.R.L." with a registered office address at Sarmiento 663, Piso 3, Buenos Aires, registered with the Public Business Register on 4 October 2005, under No 7455, Book 123 of limited liability companies (SRLs)

7) Mr Stefano Landi is hereby authorised to make all of the amendments, deletions and additions and to carry out any other act required for entry of the present act, or any subsequent relevant documents, into the Companies' Register or any other public and/or private registers.

8) Under the Consolidated Tax Act, Presidential Decree No 917/1986 of 22 December, for income tax purposes the present merger is effective from the first day of the current financial year during which the entries provided for under Article 2504 of the Italian Civil Code are made and therefore from 1 January 2017, while for the purposes of Article 2504-bis(7) of the Civil Code, the merger will become effective from the date of the last of the said entries under Article 2504 of the Italian Civil Code.

9) Direct and ancillary costs of the present act, as well as all relevant taxes and fees, will be paid by the absorbing company. The persons appearing, once again acting in their respective capacities as stated above, have requested that a fixed-rate

registry tax be applied to the present merger in accordance with Article 4 of the Tariffs Schedule, Part 1 annexed to the Consolidated Registry Tax Act, Presidential Decree No 131/1986 of 26 April.

For the purposes of recording of the present act in the protocol, the parties acknowledge that the value of the present act is approximately EUR 81,000.00.

Stamp tax has been paid in accordance with Decree of 22.2.2007 using the M.U.I. (Consolidated Electronic Form).
