**TERMINATION AND RELEASE OF SECURITY INTERESTS  
IN INTELLECTUAL PROPERTY**

**THIS TERMINATION AND RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY**, dated as of December 20, 2023, is made by CAPITAL ONE, NATIONAL ASSOCIATION, a national banking association, as agent for the Secured Parties (“**Agent**”) to P&F INDUSTRIES, INC., a Delaware corporation, FLORIDA PNEUMATIC MANUFACTURING CORPORATION, a Florida corporation, HY-TECH MACHINE, INC., a Delaware corporation, JIFFY AIR TOOL, INC., a Delaware corporation, ATSCO HOLDINGS CORPORATION., a Delaware corporation, BONANZA PROPERTIES CORP, a Delaware corporation, COUNTRYWIDE HARDWARE, INC., a Delaware corporation, EMBASSY INDUSTRIES, INC., a New York corporation, EXHAUST TECHNOLOGIES INC., a Delaware corporation, CONTINENTAL TOOL GROUP, INC., a Delaware corporation, HY-TECH ILLINOIS, INC., a Delaware corporation, formerly known as DaVinci Acquisition Corporation, and a Delaware corporation, and HEISMAN ACQUISITION CORP., a Delaware corporation, (each a “**Grantor**” and collectively, “**Grantors**”). All capitalized terms used herein but not otherwise defined herein have the meaning given to them in the IP Security Agreement.

**WHEREAS**, pursuant to that certain Joinder Agreement and Supplement to Trademark Security Agreement dated as of January 14, 2022 (as amended, supplemented or modified and in effect from time to time, the “**IP Security Agreement**”) by and among the Grantors and the Agent, the Grantors granted to the Agent a lien on and security interest in the US Trademarks set forth on Schedule A thereto (the “**IP Collateral**”); and

**WHEREAS**, an executed copy of the IP Security Agreement was recorded with the United States Patent and Trademark Office January 14, 2022, at Reel 007559, Frame 0938; and


**WHEREAS**, the Agent has agreed to terminate and release its security interest in all of such US Trademarks, including, without limitation, the US Trademarks identified on Schedule 1 attached hereto, being the same US Trademarks set forth on Schedule A to the IP Security Agreement.

**NOW, THEREFORE**, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminates the IP Security Agreement, and terminates and releases the liens and security interests created under the IP Security Agreement in the IP Collateral, , and (b) discharges any and all rights, title and interest it has in and the security interests granted to the Agent in the IP Collateral.
