RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "**Release**") is made as of December 21, 2023, by **REPUBLIC BANK & TRUST COMPANY**, a Kentucky banking corporation ("**Secured Party**").

WHEREAS, Louisville Bats, LLC, a Delaware limited liability company ("**Debtor**"), granted to Secured Party a security interest in Debtor's trademarks set forth on Schedule A (the "**Trademarks**") pursuant to a Trademark Security Agreement dated as of May 25, 2017 (the "**Original Security Agreement**"), as amended by that certain Third Omnibus Modification Agreement and Limited Waiver dated as of August 12, 2020 (the "**Modification**"). The Modification, together with the Original Security Agreement, shall hereafter be collectively referred to as the "**Security Agreement**".

WHEREAS, the Original Security Agreement was recorded on May 26, 2017 in the records of the United States Patent and Trademark Office, Assignment Branch (the "**USPTO**"), at Reel 6069, Frame 0557 and the Modification was recorded on August 14, 2020 in the records of the USPTO at Reel 7022, Frame 0234; and

WHEREAS, Secured Party wishes to: (i) release its security interest in the Trademarks; and (ii) restore all right, title and interest in and to the Trademarks to Debtor.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Secured Party does hereby release its security interest in the Trademarks, and discharges, quit claims and relinquishes unto Debtor (without recourse and without representation or warranty) any and all rights, title and interest it has in and to the Trademarks. Debtor (and any successor to Debtor, including any person or entity hereafter holding any right, title or interest in and to the Trademarks) is hereby authorized to record this Release in Trademark with the USPTO.
