RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY ("**Release**") is made as of November 10, 2023 ("**Effective Date**"), by GOLUB CAPITAL MARKETS LLC, as Collateral Agent ("**Collateral Agent**"), in favor of Timesavers, LLC, a Delaware limited liability company ("**TS**").

WHEREAS, pursuant to the terms of (i) a First Lien Security Agreement Supplement dated December 10, 2021 and a Second Lien Security Agreement Supplement dated December 10, 2021 (the "**Security Agreements**") and (ii) a First Lien Intellectual Property Security Agreement dated December 10, 2021 and a Second Lien Intellectual Property Security Agreement dated December 10, 2021 ("**IP Security Agreements**"); capitalized terms used herein but not otherwise defined having the meaning in the applicable Security Agreement or applicable IP Security Agreement, as applicable), Timesavers, Inc., an Alabama corporation (the "**Grantor**"), granted to the Collateral Agent, as collateral agent for certain secured parties, a security interest in and to all of Grantor's right, title and interest in and to certain Collateral (as defined in the respective IP Security Agreements), whereby such scheduled Collateral included certain trademark registrations and a U.S. patent registered in the name of TS;

WHEREAS, the IP Security Agreements scheduling the trademark registrations and U.S. patent listed on Schedule A hereto (collectively, "**Released IP Collateral**") were recorded with the United States Patent and Trademark Office at Reel 007529, Frame 0573; at Reel 007529, Frame 0634; at Reel 058389, Frame 0921; and at Reel 058390, Frame 0001, respectively;

WHEREAS, as of the Effective Date, the Collateral Agent hereby releases its liens on the Released IP Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby covenants and agrees as follows:

1. Collateral Agent's security interest in and to the Released IP Collateral, is hereby terminated and released.
2. To the extent Collateral Agent retains any interests whatsoever in the Released IP Collateral, Collateral Agent hereby assigns, transfers and conveys to Timesavers, LLC, a Delaware limited liability company, all of Collateral Agent's rights, title and interests, now owned or hereinafter acquired, that it may have whether by assignment or otherwise, in and to any mortgage and continuing security interests and collateral assignment in the Released IP Collateral. Such assignment, transfer and conveyance by Collateral Agent is made without any representation or warranty, express or implied.
3. The Collateral Agent authorizes and requests that the Commissioner for Patents, the Commissioner for Trademarks and any other applicable government officer record this Release.
4. This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
5. Delivery of an executed signature page to this Release by facsimile or other electronic transmission shall be effective as delivery of a manually executed signature page of this Release.
