### TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Assignment") is by and between Tara Meissner, LLC., a Nevada limited liability company with an address at 1000 N. Green Valley Parkway Suite 440 #227, Henderson, NV 89074 (the "Assignor"); and VERSALINKS HOLDINGS, LLC., a Nevada limited liability company with an address at 1000 N. Green Valley Parkway Suite 440 #227, Henderson, NV 89074 (the "Assignee"). Assignor and Assignee may be referred to collectively as the "Parties" and each a "Party" from time to time in this Assignment.

WHEREAS, Assignor is the owner of all right, title and interest in and to the federal trademark registration for "VERSALINKS" US Registration Number 6,206,367 (the "Mark"), together with the goodwill of the business;

WHEREAS, Assignee is a "successor" of Assignor pursuant to 15 U.S.C. § 1127, and Assignee's use of the Mark has inured to the benefit of the Assignor pursuant to 15 U.S.C. 1055; and

WHEREAS, Assignor believes it is in the best interests of the Parties that the Mark be assigned to the Assignee, and Assignee desires to acquire all right, title and interest in and to the Mark.

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN:

Be it known that in consideration of \$1.00 and other good and valuable consideration, the receipt and adequacy of which are acknowledged, the Parties hereby agree as set forth below.

Assignor hereby sells, assigns, transfers and conveys to Assignee the entire right, title, interest in and to the Mark in the United States and all jurisdictions outside the United States, together with the goodwill of the business connected with and symbolized by the Mark (including, without limitation, the right to renew any registrations included in the Mark, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the Mark, and any priority right that may arise from the Mark), the same to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by Assignor had this sale, assignment, transfer and conveyance not been made.

Assignor authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office and in any applicable jurisdictions outside the United States to record the transfer of the Mark to Assignee as assignee of Assignor's entire right, title and interest therein. Assignor agrees to further execute any documents reasonably necessary to effect this assignment or to confirm Assignee's ownership of the Mark.
