RELEASE OF SECURITY INTERESTS IN TRADEMARKS

This Release of Security Interests in Trademarks ("Release") is made as of the 22nd day of December, 2023 (the "Release Date"), by U.S. BANK TRUST COMPANY, NATIONAL ASSOCIATION, in its capacity as agent for the Lenders ("Agent"), as successor agent to GARRISON LOAN AGENCY SERVICES LLC, in favor of Mother's Market & Kitchen, Inc., a Delaware corporation (the "Grantor").

WHEREAS, a Trademark Security Agreement between the Agent and Grantor, dated as of July 26, 2018, was recorded on July 27, 2018 with the Assignment Recordation Branch of the U.S. Patent and Trademark Office, at Reel 6393, Frame 0749 (the "Trademark Security Agreement").

WHEREAS, Agent has agreed to terminate, release and discharge its security interest in all the trademarks subject to the Trademark Security Agreement, including the trademarks listed on Schedule A (collectively, the "Trademarks").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor and Agent hereby agree as follows:

All of Agent's security interests, liens, pledges, mortgages, and other encumbrances of any kind whatsoever created against the Trademarks pursuant to the Trademark Security Agreement (collectively, the "Security Interests") are hereby automatically terminated, released and discharged, and the Agent shall sign any additional termination documents reasonably requested by Grantor at Grantor's cost and expense, including filings with the U.S. Patent and Trademark Office against the Trademarks, as shall be necessary to effect the termination, release and discharge of all of the Security Interests, each at Grantor's cost and expense.

If and to the extent that Agent has acquired any right, title or interest in or to any of the Trademarks, it hereby assigns and transfers such rights, title or interest to Grantor, along with any goodwill in the Trademarks that the Agent may have acquired, in each case, without representation or warranty of any kind, express or implied.


