**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This Termination and Release of Security Interest in Intellectual Property (“Release”) is made as of December 18, 2023, by **MACQUARIE CAPITAL FUNDING LLC**, a Delaware limited liability company (in such capacity, together with its successors and assigns, “Collateral Agent”) in favor of **PHOCUSWRIGHT, INC.**, a Delaware corporation with an address at 100 Lighting Way, Second Floor, Secaucus, New Jersey, 07094 (“Grantor”).

**WITNESSETH:**

WHEREAS, Grantor entered into a certain Intellectual Property Security Agreement dated June 7, 2016 (the “IP Security Agreement”) with Collateral Agent, notice of which was recorded on June 24, 2016 at the United States Patent and Trademark Office at Reel 5821, Frame 0833.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

WHEREAS, Grantor granted the Collateral Agent, under the terms of the IP Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in all of its right, title and interest in and to the Trademarks, Copyrights and Patents (collectively, the “IP Collateral”), including without limitation the IP Collateral listed in **Schedule A**.


WHEREAS, the Collateral Agent has agreed to irrevocably and fully terminate and release its entire security interest in all such IP Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby automatically, irrevocably and fully releases, terminates and discharges any and all of its interest in the IP Collateral of the Grantor, including all of the goodwill of such Grantor’s business symbolized by the Trademarks and associated therewith, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest and any other liens.


