**RELEASE OF FIRST LIEN SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF FIRST LIEN SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of December 22, 2023, is made by GOLUB CAPITAL MARKETS LLC, in its capacities as administrative agent for the Lenders and as collateral agent for the Secured Parties (together with its successors in such capacities, the “Agent”) in favor of COURTHOUSE DIRECT.COM, LLC, RS ENERGY GROUP TOPCO, INC. and NAVPORT, LLC (each, a “Grantor” and, together, the “Grantors”). Capitalized terms used but not otherwise defined herein have the meanings assigned to them (including by reference) in the Security Agreement (as defined below).

WHEREAS, pursuant to that certain First Lien Pledge and Security Agreement, dated as of July 30, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), by and among Titan DI Intermediate Holdings, Inc., a Delaware corporation (“Holdings”), Enverus Holdings, Inc., a Delaware corporation (f/k/a Drilling Info Holdings, Inc.) (the “Borrower”), the Grantors, the other grantors party thereto from time to time and the Agent, the Grantor executed and delivered to the Agent that certain First Lien Intellectual Property Security Agreement, dated as of February 11, 2020 (the “IP Security Agreement”);

WHEREAS, pursuant to the Security Agreement and the IP Security Agreement, each Grantor granted to the Agent, on behalf of and for the ratable benefit of the Secured Parties, a security interest in all of its right, title and interest in and to the following, other than Excluded Assets: (a) all Trademark registrations and pending applications for Trademark registration in the United States Patent and Trademark Office listed on Schedule I hereto, including all goodwill of the business connected with the use of and symbolized by any of the foregoing; (b) the right to sue or otherwise recover for past, present and future infringements, dilutions or other violations or impairments of any of the foregoing, including the right to settle suits involving claims and demands for royalties owing; and (c) all Proceeds of the foregoing, including all income, royalties, damages, claims and payments now or hereafter due and/or payable under any of the foregoing, including damages, claims or payments for past or future infringements, dilutions or other violations or impairments of any of the foregoing (collectively, the “IP Collateral”);

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office on February 11, 2020 at Reel/Frame 6861/0965 (RS Energy Group TopCo, Inc.), Reel/Frame 6861/0956 (Courthouse Direct.com, LLC), and Reel/Frame 6861/0984 (NavPort, LLC); and


WHEREAS, the Grantors have requested that the Agent execute and deliver this Release to evidence the release of its security interest in the IP Collateral for recordation with the United States Patent and Trademark Office.

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent, without any representation, warranty or recourse of any kind or nature, hereby (a) terminates, cancels, discharges and releases its security interest in each Grantor’s right, title and interest to the IP Collateral, and (b) reassigns and retransfers to the applicable Grantor any right, title or interest the Agent may have acquired in or to the IP Collateral.
