TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this “Trademark Release”) is made as of December 19, 2023 (“Effective Date”) executed by Capital One, National Association (successor-in-interest to Healthcare Financial Solutions, LLC, who was successor-in-interest to General Electric Capital Corporation), (“Agent”), in favor of TIDI Legacy Products, Inc., TIDI Acute Care Products, Inc., TIDI Products, LLC, TIDI CFI Products, LLC, JHW TIDI Blocker, Inc., GCP TIDI Products Coinvest Inc., TP Acquisition, LLC, TIDI Holdings, LLC, TIDI Securement Products, LLC and TIDI Blocker, Inc. (each a “Grantor” and collectively the “Grantors”).

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated July 1, 2015 (the “Trademark Security Agreement”); capitalized terms used but not defined herein shall have the meaning ascribed to such terms in the Trademark Security Agreement or the Amended and Restated Guaranty and Security by the Grantors in favor of the Agent, dated as of February 28, 2017 (as the same may be amended, restated, supplemented or otherwise modified from time to time), as applicable, the Grantors granted to the Agent a continuing Lien on and security interest in and to all of the Grantors’ right, title and interest in the Trademark Collateral, including, without limitation, the pending and registered Trademarks set out on Schedule I attached hereto;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on August 27, 2015 at Reel 5610 Frame 0509; and

WHEREAS, pursuant to the Omnibus Agency Transfer Agreement between General Electric Corporation (“Retiring Agent”) and Healthcare Financial Solutions, LLC (“Successor Agent”) an Assignment of Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on November 23, 2015 at Reel 5674 Frame 0199; and

WHEREAS, the Agent wishes to terminate the Trademark Security Agreement and release and restore all right, title and interest in and to the Trademark Collateral to the Grantors and to dissolve those liens and encumbrances created by the Trademark Security Agreement in respect of the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby (i) terminates the Trademark Security Agreement, (ii) terminates, cancels and releases any and all security interests or Liens it has and all of its right, title and interest in, to and under the Trademark Collateral, whether now owned or hereafter created or acquired by the Grantors, (iii) reassigns, grants and conveys to Grantors, without any representation, recourse or undertaking by the Agent, any and all of the Agent’s right, title and interest in and to the Trademarks and Trademark Licenses, (iv) agrees, at the expense of the Grantors, to take any reasonable actions and to execute, acknowledge, procure and deliver any further documents necessary or reasonably requested by the Grantors to effectuate, record or evidence the release of the Agent’s security interest in the Trademark Collateral and (v) authorizes the Grantors to request that the United States Patent and Trademark Office record this Termination and Release of Trademark Collateral.
