PARTIAL RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS

December 27, 2023

WHEREAS, QGIV, INC., a Florida corporation (the “**Grantor**”) granted a security interest to WELLS FARGO BANK, NATIONAL ASSOCIATION, with offices at 1800 Century Park East, Suite 1100, Los Angeles, CA 90067 (the “**Grantee**”) in and lien upon certain trademarks as set forth in that certain Trademark Security Agreement dated July 19, 2022 by the Grantor in favor of the Grantee (the “**Trademark Security Agreement**”), which was recorded in the United States Patent and Trademark Office (the “**USPTO**”) on July 19, 2022 at Reel 7794, Frame 0913; and

WHEREAS, the Grantor has requested that the Grantee release and reassign to the Grantor its interest in the trademarks identified in **Schedule A** hereto and made a part hereof;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Grantee hereby:

1. Releases, terminates, fully discharges and reassigns to Grantor any and all liens, security interests, right, right of control, title and interest of Grantee pursuant to the Trademark Security Agreement in, to and under the trademarks identified in **Schedule A** and/or any goodwill associated with any of the trademarks identified in **Schedule A**, without recourse or representation or warranty, express or implied of any kind;

2. to the extent that Grantee has any remaining right or interest in Grantor’s trademarks identified in **Schedule A**, Grantee hereby assigns and agrees to assign such remaining right or interest to Grantor; and


3. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.

Notwithstanding the foregoing, the Trademark Security Agreement remains in full force and effect with respect to any and all trademarks other than the trademarks identified on **Schedule A**.
