**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 20, 2023 (“Release”), is made by Bank of America, N.A. (“Lender”) in favor of Worcester Red Sox Baseball Club, LLC (successor by merger to Pawtucket Red Sox Baseball Club, LLC), a Massachusetts limited liability company (“Grantor”).

**WHEREAS**, pursuant to that certain Second Amended and Restated Security and Pledge Agreement dated as of February 28, 2020 (as amended, restated, amended and restated, extended, supplemented or otherwise modified from time to time, the “Security Agreement”) by and among the Grantor, Lender, and others party thereto, Grantor granted a continuing security interest in and pledged and assigned to the Lender, together with a right to set off against, all rights, title and interest of the Grantor in and to Trademarks, including the trademark registrations and trademark applications listed on Schedule A attached hereto (collectively, “Trademark Collateral”); and

**WHEREAS**, pursuant to the Security Agreement, Grantor executed and delivered to Lender the Notice of Grant of Security Interest in Trademarks recorded at the United States Patent and Trademark Office (“USPTO”) on March 2, 2020 at Reel 6879 Frame 0295 (“Notice”).

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender and Grantor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice.

**SECTION 2. Termination and Release.** Lender, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in, and the right to set off against, all rights, title and interest of the Grantor in and to the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Notice; and

(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.

**IN WITNESS WHEREOF**, the Lender has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
