TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT, dated as of December 8, 2023 (this “Agreement”), by each of the signatories hereto designated as a Grantor on the signature pages hereto (together with any other entity that may become a party hereto as a Grantor as provided herein (each, a “Grantor” and collectively, the “Grantors”)), in favor of FEAC AGENT, LLC, in its capacity as administrative agent pursuant to the Credit Agreement (as defined in the U.S. Security Agreement, defined below) (in such capacity, the “Administrative Agent”), for the benefit of the Secured Parties.

WITNESSETH:

WHEREAS, the Grantors are parties to a U.S. Security Agreement, dated as of December 8, 2023 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “U.S. Security Agreement”) in favor of the Administrative Agent for the several banks and other financial institutions or entities from time to time party to the Credit Agreement (as defined in the U.S. Security Agreement) (the “Lenders”), among Dorel Industries Inc., a corporation organized under the laws of the Province of Quebec, the Lenders and the Administrative Agent, pursuant to which the Grantors are required to execute and deliver this Agreement;

NOW, THEREFORE, in consideration of the premises and to induce the Administrative Agent, for the Lenders, to enter into the Credit Agreement, the Grantors hereby agree with the Administrative Agent as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the U.S. Security Agreement and used herein have the meaning given to them in the Credit Agreement or the U.S. Security Agreement.

SECTION 2. Grant of Security Interest. The Grantors hereby grant to the Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in and continuing Lien on, all of its right, title and interest in the following Collateral (excluding any Excluded Assets) of the Grantors: all Trademarks of the Grantors, including without limitation, those Trademarks listed on Schedule I attached hereto, together with the goodwill related to the same.

SECTION 3. The Security Agreement. The security interest granted pursuant to this Agreement is granted in conjunction with the security interest granted to the Administrative Agent, for the benefit of the Secured Parties, pursuant to the U.S. Security Agreement and the Grantors hereby acknowledge and affirms that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademarks made and granted hereby and thereby are more fully set forth in the U.S. Security Agreement, the terms of which are incorporated herein by reference. In the event that any provision of this Agreement is deemed to conflict with the U.S. Security Agreement, the provisions of the U.S. Security Agreement shall control.

SECTION 4. Termination and Release. Upon the Termination Date, the Administrative Agent shall, at the expense of the Grantors, execute, acknowledge, and deliver to the Grantors an instrument in writing in recordable form releasing the lien on and security interest in the Trademarks under this Agreement. Upon any other release of any Trademarks pursuant to Section 7.15 of the U.S. Security Agreement, the Administrative Agent shall, at the expense of the Grantors, execute, acknowledge, and deliver to the Grantors an instrument in writing in recordable form releasing the lien on and security interest in the applicable Trademarks under this Agreement.

SECTION 5. Counterparts. This Agreement may be executed by one or more of the parties to this Agreement on any number of separate counterparts, and all of said counterparts taken together shall be deemed to constitute one and the same instrument. Delivery of an executed signature page of this Agreement by email or facsimile transmission shall be effective as delivery of a manually executed counterpart hereof.

SECTION 6. Governing Law. THIS AGREEMENT AND ANY CLAIM, CONTROVERSY OR DISPUTE ARISING UNDER OR RELATED TO THIS AGREEMENT, WHETHER IN TORT, CONTRACT (AT LAW OR IN EQUITY) OR OTHERWISE, SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.




