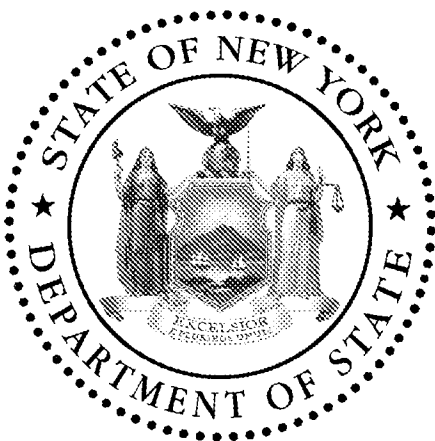

It is hereby certified, upon behalf of each of the constituent entities herein named, as follows:

FIRST: The name of the domestic constituent corporation is Simon & Schuster, Inc. (the "Merged Corporation") and the name under which it was formed is Publishing Enterprises, Inc. The name of the domestic constituent limited liability company is Century NY NewCo, LLC (the "LLC"). The Merged Corporation shall merge with and into the LLC, with the LLC as the surviving constituent entity.

SECOND: The date upon which the certificate of incorporation of the Merged Corporation was filed with the Department of State is March 20, 1957. The date upon which the articles of organization of the LLC (the "Articles of Organization") were filed with the Department of State is October 25, 2023.

THIRD: The name of the surviving domestic limited liability company is Simon & Schuster, LLC.

FOURTH: As of the Effective Date (defined below), paragraph 1 of the Articles of Organization relating to the name of the LLC is hereby amended to read as follows:

FIFTH: The Board of Directors of the Merged Corporation and the Board of Managers of the LLC have each duly adopted an agreement and plan of merger, dated as of October 26, 2023 (the "Plan of Merger"), setting forth the terms and conditions of the merger of said entities. The merger herein certified was authorized in respect of the Merged Corporation by the written consents of its Board of Directors and sole shareholder, and in respect of the LLC by the written consents of its Board of Managers and sole member.

SIXTH: The effective date of the merger of the Merged Corporation with and into the LLC is October 26, 2023 (the "Effective Date").

SEVENTH: The Secretary of State is hereby designated as the agent of the surviving limited liability company upon whom process against it may be served. The post office address to which the Secretary of State shall mail a copy of any process against the surviving limited
