INTELLECTUAL PROPERTY ASSIGNMENT

This Intellectual Property Assignment (this “**Assignment**”), effective as of October 5, 2022, is by and between Enviroscint, Inc., a Delaware corporation having a principal place of business at 4600 Roswell Road, Suite D210, Atlanta, Georgia 30342 (“**Assignor**”), on the one hand, and Scentsicles Seasonal Products Co., LLC, a Delaware limited liability company having a principal place of business at 2 Commerce Drive, Cranford, New Jersey 07016 (“**Assignee**”), on the other hand. All capitalized terms used, but not defined herein, shall have the meanings ascribed to such terms in the Asset Purchase Agreement (defined herein below).

WHEREAS, Assignor and Assignee are parties to that certain Asset Purchase Agreement, dated October 5, 2022 (the “**Asset Purchase Agreement**”), pursuant to which Assignor has agreed to sell, convey, assign and transfer to Assignee all rights, title and interests in, to and under the Business Intellectual Property, including, but not limited to, certain Intellectual Property listed on **Schedule A** hereto (the “**Assigned IP**”); and

WHEREAS, pursuant to the Asset Purchase Agreement, Assignor and Assignee have agreed to enter into this Assignment.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Conveyance. Assignor, on behalf of itself and its respective Affiliates, does hereby sell, convey, assign and transfer to Assignee all of Assignor’s right, title and interest in and to the Assigned IP, including, but not limited to: (i) all causes of action (either in law or equity) and the right to sue, counterclaim and recover for past, present and future infringement, dilution, unfair competition or other violation of the applicable Assigned IP; (ii) all income, royalties, damages and payments now or hereafter due or payable with respect to the applicable Assigned IP; (iii) all rights corresponding to the applicable Assigned IP throughout the world, for Assignee’s own use and enjoyment, and for the use and enjoyment of Assignee’s successors, assigns or other legal representatives; and (iv) all goodwill associated with the Assigned IP.

2. Recordation. Assignor hereby requests the Commissioner of Patents and Trademarks and any other applicable governmental entity or registrar (including any applicable foreign or international office or registrar), to record Assignee as the owner of the trademarks, domain names, social media accounts or other Assigned IP (as applicable) transferred to Assignee hereunder, and to issue any and all trademarks, domain names, social media accounts or other Assigned IP (as applicable) transferred to Assignee hereunder to Assignee, as assignee of the entire right, title and interest in, to and under the same, for the sole use and enjoyment of Assignee, its successors, assigns or other legal representatives. At the request of Assignee, Assignor shall execute a recordable short-form assignment agreement for purposes of recording the assignment

of applicable Assigned IP with any applicable government entity and registrar so as to perfect its ownership of the applicable Assigned IP.

3. Successors and Assigns. This Assignment shall be binding upon and inure solely to the benefit of each party hereto and their respective successors and permitted assigns, and nothing in this Assignment, express or implied, is intended to or shall confer upon any other person any rights, interests, benefits or remedies of any nature whatsoever under or by reason of this Assignment.

4. Further Assurances. Assignor shall do and perform, or cause to be done and performed, all such further acts and things, and shall execute and deliver all such other certificates, instruments, and documents, as Assignee may reasonably request in order to carry out the intent and accomplish the purposes of this Agreement, including to perfect Assignee's ownership of and record title in the applicable Assigned IP. This Assignment is being executed solely to give effect to the transactions contemplated by the Asset Purchase Agreement, and is not intended to, nor will it be construed to, modify, expand or limit in any way the terms of the Asset Purchase Agreement. To the extent that any provision of this Assignment conflicts or is inconsistent with the terms of the Asset Purchase Agreement, the Asset Purchase Agreement will govern.

5. Assignment. Assignee may assign or otherwise transfer its rights under this Assignment, including to any Affiliate of Assignee.

6. Counterparts. This Assignment may be executed in one or more counterparts (including by means of facsimile), any one of which need not contain the signatures of more than one party, but all such counterparts taken together will constitute one and the same instrument. Delivery of an executed counterpart of a signature page to this Assignment by facsimile shall be effective as delivery of a manually executed counterpart of this Assignment.

7. Section Headings. The section headings contained in this Assignment are inserted for reference purposes only and shall not affect in any way the meaning or interpretation of this Assignment.

8. Governing Law. This Assignment shall be governed by and construed in accordance with the internal laws of the State of Delaware without giving effect to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction) that would cause the application of Laws of any jurisdiction other than those of the State of Delaware. Any legal suit, action or proceeding arising out of or based upon this Assignment or the transactions contemplated hereby may be instituted in the federal courts of the United States of America located in the State of Delaware or the courts of the State of Delaware, and each party irrevocably submits to the exclusive jurisdiction of such courts in any such suit, action or proceeding. The parties irrevocably and unconditionally waive any objection to the laying of


