TERMINATION AGREEMENT OF TRADEMARK LICENSE

This Agreement entered into by and between TOURISTIC TRADE CONSULTING, INC., a Delaware corporation hereinafter referred to as the "Licensor," and TRAVEL MANAGEMENT CONSULTING, INC., an Illinois corporation, hereinafter referred to as the "Licensee", each a "Party" and collectively hereinafter referred to as the "Parties".

RECITALS

WHEREAS, Alfonso Rizzuto, an individual, as owner of the below-listed trademarks ("Trademarks") entered into a Trademark Licensing Agreement with the Licensee, TRAVEL MANAGEMENT, INC., effective January 1, 2022 (the "License") for the purpose of granting the use of the Trademarks registered before the US Patent and Trademark Office ("USPTO"):

WHEREAS, on December 29, 2022, a Memorandum of the License was registered with the USPTO, as identified in Reel/Frame No. 7934/0073 by the USPTO.

WHEREAS, on June 1, 2023, Alfonso Rizzuto transferred his rights to the Trademarks and the License to Piangiu Holdings, Inc., a corporation incorporated under the laws of Canada.

WHEREAS, thereafter, on June 1, 2023, Piangiu Holdings, Inc. assigned and transferred the Trademarks and the License to the Licensor.

NOW THEREFORE, it is hereby agreed by and between the Parties, as follows:

1. RECITALS. The Parties hereby agree that the aforementioned Recitals are contractual and form a part of this Agreement.
2. EARLY TERMINATION. Both Parties agree to terminate the License prematurely. The termination will take effect from the date of signing this Agreement and shall be immediately enforceable. 
3. EXTINGUISHMENT OF OBLIGATIONS. With the termination of the License, all obligations and rights derived from the License shall be extinguished and without any effect between the parties.
4. DELIVERY OF DOCUMENTATION. If and when applicable, the Licensee undertakes to return to the Licensor all documents, materials, and elements related to the licensed Trademarks, including but not limited to logos, digital files, usage manuals, and any other material provided by the Licensor for the exercise of the License. The return shall be completed within 10 days following the Licensor's request.

5. CONFIDENTIALITY. Both Parties agree to maintain the confidentiality of all information and documentation provided by the other Party during the term of the License. This obligation of confidentiality shall continue to exist after the termination of the License.

6. APPLICABLE LAW AND JURISDICTION. This Agreement shall be governed and interpreted in accordance with the laws of the United States. Any dispute arising from this Agreement shall be submitted to the competent courts located in Chicago, Illinois.

The Parties, duly represented, express their agreement and sign this Termination Agreement of Trademark License on June 1, 2023.


