TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (“Agreement”) is made effective as of December 29, 2023 (the “Effective Date”), by and between **Hello Digit, Inc.**, a Delaware corporation, 100 Pine Street, 20th Floor, San Francisco, CA 94111, (the “Assignor”) and **Oportun, Inc.**, a Delaware corporation, Two Circle Star Way, San Carlos, CA 94070 (the “Assignee”) (individually, a “Party,” and collectively, the “Parties”).

WHEREAS, Assignor owns the following unregistered trademarks, and the entire business, which is ongoing and existing, to which the underlying trademark pertains (“Marks”):

- U.S. Registration No. 5063829 for SAVE MONEY, WITHOUT THINKING ABOUT IT.

WHEREAS, Assignee is a successor to Assignor’s business to which the Marks pertain and desires to acquire the Marks, and all associated goodwill and business in said Marks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. Assignment. Assignor hereby irrevocably assigns and transfers to Assignee its successors and assigns all right, title and interest in and to the Marks, together with the goodwill of the business, and the business, symbolized by the Marks.

2. Recordal. Assignor hereby authorizes Assignee’s representatives to execute the necessary applications, registrations, and proprietorship forms for recordal with the respective U.S. and worldwide trademark offices.


3. Authority. The Parties hereto represent and warrant that they have full power and authority to execute, deliver and perform this Agreement and such other instruments as required herein and to consummate the transactions contemplated hereby.

4. Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the State of New York (regardless of the laws that might otherwise govern under applicable New York conflict of laws principles).


