## TRADEMARK ASSIGNMENT

Assignor hereby assigns to Assignee, its successors and assigns, Assignor’s entire right, title and interest in and to the Trademark, and all rights and privileges pertaining to said Trademark, together with the goodwill of the business symbolized by the Trademark, including all income, royalties, damages, and payments now or hereafter due or receivable in respect of the Trademark, and all causes of action (either in law or equity) and the right to sue, counterclaim, and recover for past, present, and future infringements, misappropriations, or dilutions of the rights assigned to Assignee hereunder, and all rights corresponding thereto throughout the world.

2. And for the above-named consideration, Assignor does hereby agree to, at the request of the Assignee, execute any and all papers and documents and do all other and further lawful acts that the Assignee may deem necessary or desirable to perfect and vest in the Assignee the entire right, title and interest in the Trademark being assigned.
