**RELEASE OF TRADEMARK SECURITY AGREEMENT**

THIS RELEASE dated as of December 28, 2023 (this “Release”) is made by Kayne Senior Credit IV Loanco, LLC, acting in its capacity as administrative agent (in such capacity, the “Administrative Agent”) under that certain Trademark Security Agreement, dated as of December 23, 2019 (the “Trademark Security Agreement”) by TechPro Power Solutions, LLC (the “Grantor”) in favor of the Administrative Agent.

WHEREAS, pursuant to the Trademark Security Agreement, which was recorded in the records of the United States Patent and Trademark Office on December 24, 2019 at Reel 006825, Frame 0412, the Grantor granted to the Administrative Agent a continuing security interest in all of the Grantor’s right, title and interest in, to and under its owned or thereafter acquired Trademark Collateral (as defined in the Trademark Security Agreement), including those trademark and service mark registrations and applications set forth on Schedule I attached hereto; and

WHEREAS, the Grantor has requested and the Administrative Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in and reassignment of the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Trademark Collateral, (b) release its security interest in the Trademark Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Administrative Agent in the Trademark Collateral and (d) reassign to the Grantor any and all right, title and interest that it may have in the Trademark Collateral owned by the Grantor.

The laws of the State of New York shall govern all matters arising out of, in connection with or relating to this Release, including its validity, interpretation, construction, performance and enforcement (including any claims sounding in contract or tort law arising out of the subject matter hereof and any determinations with respect to post-judgment interest).
