
NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS

LLC (fka SWIFTPAGE ACT! LLC), a Delaware limited liability company (each, a "Grantor"), in favor of AB PRIVATE CREDIT INVESTORS LLC, as collateral agent (in such capacity, the "Collateral Agent"), which was duly recorded on June 15, 2018, at Reel/Frame 006353/0600, in the United States Patent and Trademark Office, and any other right, title or interest granted to the Collateral Agent in the Trademark Collateral, including (i) the trademarks set forth on Schedule 1 attached hereto, (ii) all renewals, continuations and extensions thereof, (iii) all goodwill of the business connected with the use of, and symbolized by, each such trademark, and (iv) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof, without representation or warranty, (b) terminates the Agreement, and (c) re-assigns to each Grantor any right, title or interest it may have in or to any of the Trademark Collateral, including the trademarks set forth on Schedule 1.
