**RELEASE OF SECURITY INTEREST**

This Release of Security Interest is made as of January 2, 2024, by Montage Capital II, L.P. WHEREAS, Company has no outstanding obligations to Lender under the terms of the above referenced security agreements, Lender agrees to release its security interest in the Intellectual Property.


Agreement
