**RELEASE OF SECURITY INTEREST  
IN  
TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “*Release*”), dated as of December 21, 2023, is made by Fifth Third Bank, National Association, as administrative agent for the Secured Creditors (in such capacity and together with any successors and assigns in such capacities, the “*Administrative Agent*”), in favor of MEDHOST Cloud Services, Inc., a Delaware corporation, MEDHOST Direct, Inc., a Tennessee corporation, and MEDHOST of Tennessee, Inc., a Tennessee corporation, (each, a “*Grantor*” and collectively, the “*Grantors*”) under that certain Trademark Collateral Agreement, dated as of December 29, 2021 (as may have been amended, restated, supplemented or otherwise modified from time to time, the “*Trademark Collateral Agreement*”) by and among the Grantors and the Administrative Agent.

WITNESSETH

WHEREAS, pursuant to the Trademark Collateral Agreement, each Grantor granted to the Administrative Agent a security interest in all of such Grantor’s right, title and interest in, to and under the trademark collateral described in detail therein (such collateral, the “*Trademark Collateral*”); and

WHEREAS, the Grantors request that the Administrative Agent release, discharge, terminate and cancel its security interest in and to the Trademark Collateral, including but not limited to the trademark registrations and applications listed on Schedule A attached hereto, together with the goodwill connected with the use of and symbolized thereby and all extensions and renewals thereof.


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent, without recourse, representation or warranty of any kind or nature, and at the Grantors’ sole cost and expense, hereby releases, discharges, terminates and cancels its remaining security interest in and to the Trademark Collateral.

1. The Administrative Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release.
2. The validity, interpretation and enforcement of this Release and any dispute arising out of the relationship between the parties hereto, whether in contract, tort, equity or otherwise, shall be governed by and construed in accordance with the laws of the State of New York, without regard to conflict of law provisions (other than Sections 5-1401 and 5-1402 of the New York General Obligations law).
3. Capitalized terms used but not defined herein shall have the meanings given to them in the Trademark Collateral Agreement.
4. Delivery of an executed signature page to this Release by electronic transmissions (including .pdf file) shall be effective as delivery of an original signature.
