TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT ("**Trademark Assignment**"), dated as of July 25, 2019, is made by Glen Oak Lumber & Milling, Inc., a Wisconsin corporation ("**Glen Oak**"), in favor of Charles T. Talbot, an individual having an address of 5575 Meridian Way, Oakwood, Georgia 30566 ("**Talbot**").

WHEREAS, Glen Oak has been dissolved and, pursuant to Section 180.1405 of the Wisconsin Statutes, has distributed, conveyed, transferred, and assigned to Talbot as its sole shareholder, among other assets, certain intellectual property of Glen Oak, and has agreed to execute and deliver this Trademark Assignment, for recording with the United States Patent and Trademark Office;

NOW THEREFORE, Glen Oak agrees as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Glen Oak hereby irrevocably conveys, transfers, and assigns to Talbot all right, title, and interest in and to the trademark ACORN OAK, including without limitation U.S. Trademark Reg. No. 2,859,932 for the mark ACORN OAK, and all issuances, extensions, and renewals thereof (the "**Assigned Trademark**"), together with the goodwill associated therewith and symbolized thereby.

2. Recordation and Further Actions. Glen Oak hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office to record and register this Trademark Assignment upon request by Talbot. Glen Oak shall take such steps and actions and provide such cooperation and assistance to Talbot and his successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence, or perfect the assignment of the Assigned Trademark to TTI, or any assignee or successor thereto.

3. Counterparts. This Trademark Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Trademark Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Trademark Assignment.
