TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT ("**Trademark Assignment**"), dated as of October 21, 2023, is made by Charles T. Talbot, an individual having an address of 5575 Meridian Way, Oakwood, Georgia 30566 ("**Talbot**"), in favor of Tom Talbot, Inc., a Wisconsin corporation, having an address of 1150 W. Main St., Sun Prairie, WI 53590-1911 ("**TTI**").

WHEREAS, Talbot wishes to sell to TTI, and TTI wishes to purchase from Talbot, all right, title, and interest in and to a certain trademark and related rights, together with the goodwill connected with the use of and symbolized by such trademark, subject to the terms and conditions set forth herein.

NOW THEREFORE, Talbot agrees as follows:

1. Assignment. For consideration of \$2500 and good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Talbot hereby irrevocably conveys, transfers, and assigns to TTI all right, title, and interest in and to the trademark ACORN OAK, including without limitation U.S. Trademark Reg. No. 2,859,932 for the mark ACORN OAK, and all issuances, extensions, and renewals thereof (the "**Assigned Trademark**"), together with the goodwill associated therewith and symbolized thereby.

2. Recordation and Further Actions. Talbot hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office to record and register this Trademark Assignment upon request by TTI. Talbot shall take such steps and actions and provide such cooperation and assistance to TTI and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence, or perfect the assignment of the Assigned Trademark to TTI, or any assignee or successor thereto.

3. Counterparts. This Trademark Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Trademark Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Trademark Assignment.
