## TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST

WHEREAS Gardner Glass Products, Inc., a North Carolina corporation (the "Company"), entered into that certain Intellectual Property Security Agreement dated December 20, 2011 (the "Security Agreement"), by and between the Company and FCC, LLC d/b/a First Capital, a Florida limited liability company ("First Capital"), a true and correct copy of which was recorded by the United States Patent and Trademark Office on January 27, 2012 at Reel/Frame No. 4705/0737;

WHEREAS, First Capital sold, assigned, and transferred its entire right, title, and interest in the Security Agreement to ACF Finco I LP, a Delaware limited partnership ("Lender"), pursuant to that certain Assignment and Assumption of Security Interests in Trademarks dated May 18, 2015 (the "Assignment Agreement"), a true and correct copy of which was recorded by the United States Patent and Trademark Office on May 19, 2015 at Reel/Frame No.; 5519/0970;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:


1. Release of Security Interest. Lender hereby:
  - a. confirms that there are no outstanding obligations owed by the Company to Lender;
  - b. releases any and all liens, security interests, right, title, and interest of Lender pursuant to the Security Agreement and the Assignment Agreement in the trademarks listed in Schedule 1 attached hereto, and all of the goodwill associated therewith, without recourse or representation or warranty, express or implied;
  - c. authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release and termination hereby given; and
  - d. authorizes the filing of this Termination and Release of Trademark Security Interest in the United States Patent and Trademark Office.
2. Further Assurances. Lender agrees to take all further actions, and provide to the Company and its successors, assigns, and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Company and its successors, assigns, and legal representatives may reasonably request in order to confirm, effectuate, and/or record this Termination and Release of Trademark Security Interest.
