TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this “Assignment”), dated as of November 27, 2023 (the “Effective Date”), is by and among (i) Warnaco Inc., a Delaware corporation, Warnaco U.S., Inc., a Delaware Corporation, and True & Co., Delaware, a Delaware corporation (collectively, “Assignors”) and (ii) BRIIPCO Ltd., an Ireland company (“Assignee”). Assignors and Assignee are collectively referred to herein as the “Parties” and individually referred to herein as a “Party”. Reference is made to the Asset Purchase Agreement, dated as of November 10, 2023 (the “APA”), by and among PVH Corp., a Delaware corporation, PVH Canada, Inc., a Nova Scotia corporation, Basic Resources, Inc., a New York corporation, BR Intimates LLC, a Delaware limited liability company, Assignee and Assignors. Capitalized terms not otherwise defined herein shall have the meaning ascribed to such terms in the APA.

RECITALS

WHEREAS, pursuant to the terms and subject to the conditions set forth in the APA, Sellers have agreed to sell, assign, transfer and convey to Purchasers all of the Sellers right, title and interest in and to the Acquired Assets, including an assignment to Assignee of all of Assignors’ right, title and interest in and to the trademarks identified on Schedule I attached hereto (collectively, the “Assigned Trademarks”), including the goodwill associated with such Assigned Trademarks; and

WHEREAS, at the Closing of the transactions contemplated by the APA, Assignors shall execute and deliver this Assignment to Assignee, in order to effectuate the assignment of the Assigned Trademarks pursuant to a document suitable for recordation with all applicable governmental authorities and registrars so as to record ownership of the Assigned Trademarks.

NOW, THEREFORE, in consideration of the mutual promises and covenants set forth below, the receipt and sufficiency of which are hereby acknowledged:

ARTICLE I TRADEMARK ASSIGNMENT

Section 1.1 Each Assignor hereby irrevocably assigns to Assignee all of its rights, title and interest in and to the Assigned Trademarks as of the Effective Date, including any and all goodwill appurtenant thereto held by such Assignor together with the right to sue and recover and retain damages and profits for past, present and future infringement, misappropriation or other violation of the foregoing, if any. The Assigned Trademarks shall be held and enjoyed by Assignee, its successors and assigns as fully and entirely as the same would have been held and enjoyed by such Assignor had this assignment not been made.

Section 1.2 Promptly following the Effective Date, Assignors shall cause (i) the recordable assignment attached as each of Exhibit A-1, Exhibit A-2 and Exhibit A-3 hereto and such other recordable assignments requested by Assignee (collectively, the “Recordable Trademark Assignments”) and (ii) one or more Power of Attorney, if requested by Assignee, the forms of which are attached hereto as Exhibit B, in each case, to be executed and delivered to Assignee or its designee. Each Assignor hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office, and the officials of corresponding entities or

agencies in any applicable jurisdictions to record and register the Recordable Trademark Assignments upon request by Assignee, its successors, assigns or other legal representatives.

Section 1.3 Promptly following the Effective Date, Assignors will cooperate with Assignee and follow Assignee's reasonable instructions, at Assignee's sole cost and expense, in order to promptly effectuate the transfer of rights to Assignee contemplated hereunder, and any necessary or appropriate records or indicia of ownership and use. Without limiting the foregoing, each Assignor agrees at all times to provide Assignee with any additional information, to do any and all things, to execute any and all documents or instruction, and to follow any procedures, that may be required or reasonably requested by Assignee to effectuate the assignment hereunder. Assignee shall be solely responsible for, and shall bear all cost related to, filing or recordings of the Recordable Trademark Assignments and to effectuate the assignment hereunder.

ARTICLE II GENERAL PROVISIONS

Section 2.1 APA. The representations, warranties, covenants, agreements, and indemnities contained in the APA shall not be superseded, expanded, amended, modified or in any way affected hereby but shall remain in full force and effect to the full extent provided therein. To the extent there is any conflict between the terms and conditions of this Assignment and the terms and conditions of the APA, the terms and conditions of the APA shall control.

Section 2.2 Governing Law. This Assignment shall be governed by and construed in accordance with U.S. federal law and the laws of the State of New York, as applicable, without reference to the choice-of-law principles that would result in the application of the laws of a different jurisdiction other than the State of New York or U.S. federal law, as the case may be.

Section 2.3 Entire Agreement. This Assignment, together with the Schedules and Exhibits hereto, constitute the entire agreement between the Parties with respect to the subject matter of this Assignment and supersedes any prior discussion, correspondence, negotiation, proposed term sheet, agreement, understanding or arrangement.

Section 2.4 Amendments. This Assignment may not be modified or amended except by an instrument or instruments in writing signed by the Party against whom enforcement of any such modification or amendment is sought.

Section 2.5 Counterparts. This Assignment may be executed in one or more counterparts, each of which when executed shall be deemed to be an original but all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Assignment by electronic means shall be as effective as delivery of a manually executed counterpart of this Assignment.


