**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “*Termination and Release*”) is granted as of January 5, 2024 by **ARES CAPITAL CORPORATION**, in its capacity as Administrative Agent (the “**Administrative Agent**”) for the Secured Parties (as defined in the Second Lien Credit Agreement), in favor of **BADGER SPORTSWEAR, LLC**, a North Carolina limited liability company (f/k/a Badger Sportswear, Inc.) (the “*Grantor*”).

**WHEREAS**, the Grantor executed and delivered that certain Trademark Security Agreement, dated as of September 9, 2016 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Grant*”), granting the Administrative Agent a security interest in and lien on the Trademark Collateral (as defined therein), which was recorded with the United States Patent and Trademark Office (“*USPTO*”) on September 12, 2016, at Reel 005875, Frame 0214;

**WHEREAS**, the Grantor has requested that the Administrative Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all of the Trademark Collateral as herein provided; and

**WHEREAS**, the Grantor has requested that the Administrative Agent provide a document suitable for recording with the USPTO to evidence the release of the Administrative Agent’s security interests in and liens on the Trademark Collateral as herein provided.


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby:

1. terminates the Grant and releases, terminates and discharges all liens and security interests in the Grantor’s right, title and interest in, to and under (i) the Trademark Collateral, including without limitation those trademarks and trademark applications identified in Schedule A hereto, (ii) all proceeds and products of the Trademark Collateral, (iii) all goodwill associated therewith, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Trademark Collateral or unfair competition regarding the same; and assigns, transfers and conveys to Grantor any interest in all of the foregoing, including any lien and security interest thereof; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.
