ASSET PURCHASE AGREEMENT

Made as of November 13, 2023

ASSET PURCHASE AGREEMENT

THIS ASSET PURCHASE AGREEMENT is made as of November 13, 2023 among MAV BEAUTY BRANDS INC., a corporation organized under the laws of British Columbia, MARC ANTHONY COSMETICS LTD., a corporation organized under the laws of British Columbia, MARC ANTHONY COSMETICS USA, INC., a corporation organized under the laws of Delaware, MAV MIDCO HOLDINGS, LLC, a limited liability company formed under the laws of Delaware, RENPURE, LLC, a limited liability company formed under the laws of Delaware (each, a "Seller" and together, the "Sellers"), and MAV USA, LLC, a limited liability company organized under the laws of Delaware (the "Buyer");

WHEREAS the Sellers operate a personal care company, including a diversified portfolio of four personal care brands;

AND WHEREAS on or about the date hereof, the Sellers will file an initial application for protection from their creditors and certain relief under the *Companies' Creditors Arrangement Act* (Canada) ("**CCAA**"), including seeking court approval of Alvarez & Marsal Canada Inc. as the court-appointed monitor of the Sellers (the "**Monitor**") (the date of such filing, the "**Filing Date**");

AND WHEREAS subject to the approval of the Ontario Superior Court of Justice (Commercial List) (the "CCAA Court"), Sellers have agreed to sell, convey, assign, transfer and deliver to the Buyer or one or more of its designees, and the Buyer has agreed to purchase, acquire, assume and accept directly or through one or one or more of its designees from the Sellers the Purchased Assets (as defined herein) and the Assumed Liabilities (as defined herein), on the terms and subject to the conditions of this Agreement;

NOW THEREFORE, in consideration of the mutual covenants and agreements contained in this Agreement and other good and valuable consideration (the receipt and sufficiency of which are hereby acknowledged and confirmed), the Parties agree as follows:

ARTICLE 1 INTERPRETATION

Section 1.1 Definitions

In this Agreement,





"Intellectual Property" means any and all right, title and interest in, to, arising out of, or associated with any of the following in any jurisdiction throughout the world: (a) issued patents and patent applications (whether provisional or non-provisional), including divisionals, continuations, continuations-in-part, substitutions, reissues, foreign equivalents, international applications, reexaminations, extensions, or restorations of any of the foregoing, and other Governmental Authority-issued indicia of invention ownership (including certificates of invention, design patents, industrial designs, petty patents, and patent utility models); (b) registered or unregistered trademarks, service marks, pending trademark and service mark registrations, brands, certification marks, logos, trade dress, trade names, and other similar indicia of source or origin, together with the goodwill connected with the use of and symbolized by, and all registrations, applications for registration, and renewals of, any of the foregoing; (c) registered and unregistered copyrights and works of authorship, whether or not copyrightable. and all registrations, applications for registration, and renewals of any of the foregoing; (d) internet domain names and social media account or user names (including "handles"), whether or not they include trademarks, all associated web addresses, URLs, websites and web pages, social media sites and pages, and all content and data thereon or relating thereto, whether or not copyrights; (e) trade secrets, know-how, inventions (whether or not patentable), discoveries, improvements, technology, business and technical information, databases, data compilations and collections, tools, methods, processes, techniques, and other confidential and proprietary information and all rights therein; (f) computer programs, operating systems, applications. Software, firmware and other code, including all source code, object code, application programming interfaces, data files, databases, protocols, specifications, and other documentation thereof; and (g) all other intellectual or industrial property and proprietary rights;



ARTICLE 2 PURCHASE AND SALE

Section 2.1 Purchased Assets

Subject to the terms and conditions of this Agreement, at the Closing and effective as at 12:01 am (EST) on the Closing Date, the Sellers agree to sell, assign, transfer and convey to the Buyer or one or more of its designees, and the Buyer agrees to purchase, acquire and accept from the Sellers directly or through one or more of its designees, all of the Sellers' respective right, title and interest in and to, free and clear of all Encumbrances other than the Permitted Encumbrances (all of such assets and property, excluding for greater certainty, the Excluded Assets, hereinafter collectively referred to as the "Purchased Assets"):





(e) Intellectual Property. The Sellers' respective rights, interests and benefits (through ownership, licensing or otherwise) in and to any and all Intellectual Property, including the Intellectual Property listed in Section 2.1(e) of the Disclosure Letter, all documentation and media constituting, describing, or relating to such Intellectual Property, including memoranda, manuals, technical specifications, and other records wherever created and regardless of form, and the right to sue for past, present, or future infringement, misappropriation, or violation thereof, and to collect and retain all damages and profits related to the foregoing (collectively, the "Purchased Intellectual Property");



INTELLECTUAL PROPERTY ASSIGNMENT AND ASSUMPTION AGREEMENT

This Intellectual Property Assignment and Assumption Agreement (this "Agreement") is made as of December 8, 2023 between MARC ANTHONY COSMETICS LTD., a corporation duly incorporated under the laws of the province of British Columbia, having its head office located at 100 New Park Place, suite 810, Vaughan, Ontario, L4K 0H9 (the "Assignor") and MAV BEAUTY CANADA, INC., a corporation organized under the laws of British Columbia, having its head office located at 2200 HSBC Building, 885 West Georgia Street, Vancouver BC V6C 3E8 (the "Assignee" and, together with the Assignor, the "Parties").

RECITALS:

- a) The Assignor, MAV Beauty Brands Inc., Marc Anthony Cosmetics USA, Inc., MAV Midco Holdings, LLC, Renpure, LLC, and The Mane Choice Hair Solution LLC (collectively, the "Sellers") and MAV USA, LLC (the "Buyer") are parties to an asset purchase agreement dated November 13, 2023 (the "APA"), pursuant to which, among other things, the Assignor has agreed to sell, assign, transfer and convey to the Buyer or one or more of its designees (which includes, for greater certainty, the Assignee), and the Buyer has agreed to purchase, acquire and accept from the Assignor directly or through one or more of its designees (which includes, for greater certainty, the Assignee), all of the Assignor's right, title and interest as of the date of the APA in, and benefit to, and under, or relating to, among others, the Purchased Intellectual Property including but not limited to those set out in Schedule "A" hereto (collectively, the "Transferred IP").
- b) The Assignor and the Assignee desire to carry out the intent and purpose of the APA by their execution and delivery of this Agreement evidencing the sale, conveyance, transfer and assignment to the Assignee of all of the Assignor's right, title and interest in, and benefit to, and under, or relating to, the Transferred IP.

NOW THEREFORE in consideration of the mutual covenants and agreements contained in this Agreement and other good and valuable consideration (the receipt and sufficiency of which are acknowledged), the Parties agree as follows:

- 1. **Defined Terms**. Capitalized terms used in this Agreement and its Schedule "A" hereto, but not otherwise defined have the meanings specified in the APA.
- 2. Assignment and Assumption. Without limiting the generality of the terms of the APA, and on the terms and subject to the conditions set forth in the APA, the Assignor hereby sells, assigns, transfers and conveys to the Assignee all of the Assignor's right, title and interest in, and benefit to, and under, or relating to, the Transferred IP, all of the same to be held by the Assignee as fully and entirely as the same could have been held and enjoyed by the Assignor if this assignment had not been made, and all rights of action accrued and to accrue under and by virtue thereof.
- **3. Third Party Beneficiaries**. The Parties intend that this Agreement shall not benefit or create any right or cause of action in favor of any Person other than the Parties. No Person other than the Parties shall be entitled to rely on the provisions of this Agreement in any action, suit, proceeding, hearing or other forum.
- 4. Conflicts with the APA. Notwithstanding anything contained herein to the contrary, in the event of any inconsistency between the terms of this Agreement and the terms of the APA, the terms of the APA shall govern.
- **5. Further Assurances**. From time to time after the date hereof, the Assignor shall, at the reasonable request and sole expense of the Assignee, do, execute, acknowledge and deliver, or cause to be done, executed, acknowledged and delivered, all such further acts and additional conveyance documents as may be requested by the Assignee, acting reasonably, to permit the sale, conveyance, transfer and assignment from the Assignor to the Assignee and the acquisition by the Assignee from the Assignor of all right, title and interest in and to the Transferred IP, and to carry out the purposes and intent of this Agreement and the APA.
- **Recordation**. The Assignor hereby authorizes the Chief Executive Officer and Registrar of Trademarks in the Canadian Intellectual Property Office, and the officials of corresponding entities or agencies in any applicable jurisdictions, to record and register this Agreement upon request by the Assignee.
- Amendments. Except as expressly provided in this Agreement, no amendment or waiver of this Agreement shall be binding unless executed in writing by all Parties hereto. No waiver of any provision of this Agreement

- **8. Successors and Assigns**. This Agreement shall be binding upon and inure to the benefit of the Parties and their respective permitted successors and permitted assigns.
- 9. Governing Law. This Agreement, the rights and obligations of the Parties under this Agreement, and any claim or controversy directly or indirectly based upon or arising out of this Agreement or the transactions contemplated by this Agreement (whether based on contract, tort or any other theory), including all matters of construction, validity and performance, shall in all respects be governed by, and interpreted, construed and determined in accordance with, the laws of the Province of Ontario and the federal laws of Canada applicable therein, without regard to the conflicts of law principles thereof.
- 10. Counterparts. This Agreement may be signed in counterparts and each of such counterparts shall constitute an original document and such counterparts, taken together, shall constitute one and the same instrument. Execution of this Agreement may be made by facsimile signature or by electronic means which, for all purposes, shall be deemed to be an original signature.


