Further, Assignor agrees to execute and deliver at the request of Assignee, all documents, instruments and assignments, and to perform any other reasonable acts that Assignee may require in order to vest all Assignor’s right, title and interest in and to the Marks, together with the goodwill of the business associated therewith, in the Assignee and perfect or record this Assignment.
