RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (the “Release”) is dated as of January 5, 2024 by BLUE OWL CAPITAL CORPORATION (formerly known as OWL ROCK CAPITAL CORPORATION), as collateral agent (in such capacity, the “Collateral Agent”) in favor of MONSIDO LLC, a Delaware limited liability company (the “Grantor”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Collateral Agreement (as defined below).

WITNESSETH

WHEREAS, the Grantor and the Collateral Agent, among others, are party to that certain Collateral Agreement, dated as of August 24, 2021 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”);

WHEREAS, pursuant to the Collateral Agreement, the Grantor executed the Trademark Security Agreement, dated as of June 13, 2022 (the “Trademark Security Agreement”), and recorded with the United States Patent and Trademark Office on June 14, 2022 at Reel/Frame No. 7751/0694, pursuant to which the Grantor granted to the Collateral Agent, its successors and assigns, for the benefit of the Secured Parties, a security interest in all of Grantor’s right, title and interest in, to and under the (a) all the Trademarks and Trademark applications listed on Schedule I attached to the Trademark Security Agreement, (b) all of the goodwill of Grantor’s business connected with the use of and symbolized by such Trademarks, (c) all rights to sue or otherwise recover for any past, present and future infringement, dilution, or other violation thereof, (d) all Proceeds of the foregoing, including, without limitation, license fees, royalties, income, payments, claims, damages, proceeds of suit and other payments now or hereafter due and/or payable with respect thereto, and (e) all other rights of any kind accruing thereunder or pertaining thereto throughout the world (the “Trademark Collateral”);

WHEREAS, the Grantor has requested that the Collateral Agent release its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration of the foregoing, the receipt and sufficiency of which are hereby acknowledged, Grantor and Collateral Agent hereby agree as follows:

SECTION 1. The Collateral Agent, on behalf of itself and the Secured Parties, hereby DISCHARGES, CANCELS, TERMINATES and RELEASES, without recourse, representation or warranty, any and all security interest and all of its right, title and interest it may have in and to the Trademark Collateral, including the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and hereby agrees that all of its security interest in the Trademark Collateral is hereby discharged, cancelled, terminated and released.

SECTION 2. The Collateral Agent, on behalf of itself and the Secured Parties, hereby transfers, grants, conveys and reassigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent, or the Secured Parties, may have obtained in, to and under the Trademark Collateral under the Collateral Agreement and the Trademark Security Agreement and that any right, title, and interest of Collateral Agent or the Secured Parties in, to or under the Trademark Collateral shall hereby cease and become void. The Collateral Agent, on behalf of itself and the Secured

Parties, hereby authorizes the Grantor and its successors, assigns, designees, or other legal representatives to file this Release with the United States Patent and Trademark Office to evidence and effectuate the release and termination of Collateral Agent's and the Secured Parties' security interest in the Trademark Collateral and authorizes the Commissioner for Trademarks to record and register this Release.

SECTION 3. This Release shall be governed by and construed in accordance with the laws of the State of New York, without regard to conflicts of laws principles.
