## **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Release") is made as of December 20, 2023 ("Effective Date") executed by **BMO BANK N.A.**, a national banking association (f/k/a BMO Harris Bank N.A.), in its capacity as agent for the Lender Group and the Bank Products Providers (in such capacity, together with its successors and assigns, the "Grantee"), in favor of **REMEDI TECHNOLOGY HOLDINGS LLC**, a Maryland limited liability company ("Technology"), and **REMEDI SENIORCARE HOLDING CORPORATION**, a Maryland corporation ("SeniorCare"), and together with Technology, each a "Grantor" and collectively the "Grantors").

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated October 19, 2018 (the "Trademark Security Agreement"); capitalized terms used but not defined herein shall have the meaning ascribed to such terms in the Trademark Security Agreement (as the same may be amended, restated, supplemented or otherwise modified from time to time), the Grantors granted to the Grantee a continuing lien on and security interest in and to all of each Grantor's right, title and interest in the following Collateral owned by each Grantor in its own name and as set out on Schedule I attached hereto (collectively the "Trademark Collateral");

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on October 22, 2018 as (i) number 900470841, Reel/Frame 6511/0880, and (ii) as number 900470852, Reel/Frame 6462/0783;

**WHEREAS**, the Grantee wishes to terminate the Trademark Security Agreement and release and restore all right, title and interest in and to the Trademark Collateral to the Grantors and to dissolve those liens and encumbrances created by the Trademark Security Agreement in respect of the Trademark Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby (i) terminates the Trademark Security Agreement, (ii) terminates, cancels and releases any and all security interests or liens it has and all of its right, title and interest in, to and under the Trademark Collateral, whether now owned or hereafter created or acquired by the Grantors, (iii) reassigns, grants and conveys to Grantors, without any representation, recourse or undertaking by the Grantee, any and all of the Grantee's right, title and interest in and to the Trademarks and Trademark Licenses, (iv) agrees, at the expense of the Grantors, to take any reasonable actions and to execute, acknowledge, procure and deliver any further documents necessary or reasonably requested by the Grantors to effectuate, record or evidence the release of the Grantee's security interest in the Trademark Collateral and (v) authorizes the Grantors to request that the United States Patent and Trademark Office record this Termination and Release of Trademark Collateral.


