**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**January 24, 2024**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is effective as of October 6, 2022, and is given by COÖPERATIEVE RABOBANK U.A., NEW YORK BRANCH, in its capacity as agent for the lenders (in such capacity, the “Administrative Agent”), with its principal offices at 245 Park Avenue, New York, New York 10167, in favor of JMH INTERNATIONAL, LLC, a Georgia limited liability company (“Grantor”). Capitalized terms not defined herein shall have the meanings given to them, directly or by reference, in the Trademark Security Agreement (as defined below).

WHEREAS, the Grantor has executed and delivered that certain Supplement No. 1 to Trademark Security Agreement in favor of the Administrative Agent, dated as of April 24, 2020 and recorded on May 1, 2020 at Reel 6928, Frame 0564 (“Supplement No.1”), which supplemented that certain Trademark Security Agreement dated as of November 14, 2019, which was recorded in the Assignment Division of the United States Patent & Trademark Office on November 18, 2019 at Reel 6796, Frame 0419 (as amended, restated, supplemented, extended, or otherwise modified from time to time prior to the Release (as defined below) (the “Trademark Security Agreement”);

WHEREAS, pursuant to the Trademark Security Agreement, the Grantor and each other grantor granted to the Administrative Agent a continuing security interest (the “Security Interest”) in certain trademarks listed therein (such trademarks being the “Trademark Collateral”);

WHEREAS, the Administrative Agent released the Trademark Collateral, with the exception of the Trademark Collateral granted by the Grantor pursuant to Supplement No. 1 (such trademarks being the “Outstanding Trademark Collateral”), by entering into that certain Release of Trademark Security Agreement, dated as of October 6, 2022 and recorded on October 7, 2020 at Reel 7862, Frame 0126 (“Release”); and

WHEREAS, Administrative Agent now desires to release its Security Interest in the Outstanding Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Administrative Agent hereby (i) terminates, releases, and discharges the Security Interest in the Outstanding Trademark Collateral, and (ii) re-assigns to the Grantor any right, title or interest it may have in the Outstanding Trademark Collateral, in each case without recourse to the Administrative Agent and without representation or warranty of any kind. The Administrative Agent further agrees to execute and deliver to the Grantor any and all further documents and instruments, and do any and all further acts which the Grantor (or their agents or designees) reasonably request (at the Grantor’s sole cost and expense) in order to confirm this release and the Grantor’s right, title and interest in, to and under the Outstanding Trademark Collateral listed on Schedule 1 hereto. The Administrative Agent hereby authorizes the Grantor, or any successor to the Grantor (including any person or entity hereafter holding any right, title or interest in or to the Outstanding Trademark Collateral) to record this Release with the United States Patent and Trademark Office.
