**AMENDED ASSIGNMENT OF TRADEMARKS**

THIS AMENDED ASSIGNMENT OF TRADEMARKS is effective as of December 31, 2022 and is made by Katherine A. Whitlow and Thomas A. Cortopassi, Co-Trustees of the Administrative Trust established under the DAC/JAC Trust dated March 25, 1992, as amended and restated on November 17, 2006 (“Assignor”), in favor of Stanislaus Food Products Company, a California corporation (“Assignee”). This amendment restates and replaces the Assignment of Trademarks previously executed by the parties on December 30, 2022 and January 4, 2023 to correct two Scribner’s errors in the original document, namely, (1) the incorrect inclusion of the “, Inc.” in the name of Stanislaus Food Products Company as Assignee, and (2) the inadvertent omission of the trademark GROVE TO KITCHEN, App. No. 90221171 from the Schedule of Trademarks.

WHEREAS, Assignor owns all right, title, and interest in and to the trademarks and the applications or registrations therefor listed on the attached Schedule of Trademarks, as well as any unregistered trademarks and trade dress used at common law, (the “Marks”) and the goodwill associated therewith;

WHEREAS, the parties have executed an Intangible Asset Purchase Agreement dated December 15, 2022;

WHEREAS, Assignor desires to assign to Assignee all of its right, title, and interest in the Marks including all common law rights therein, together with the goodwill associated therewith, along with that portion of the business which is ongoing and existing to which the Marks pertain;

NOW, THEREFORE: For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns to Assignee all of its right, title, and interest in the Marks, including all common law rights therein, together with the goodwill associated therewith, along with that portion of the business which is ongoing and existing to which the Marks pertain, including, without limitation, all right to sue and collect damages, costs, and fees in Assignee’s own name for any and all past, present, or future infringement, dilution, or other violations or injury to the Marks.




