**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of October 27, 2023, by **WILMINGTON TRUST, NATIONAL ASSOCIATION**, as administrative agent and collateral agent for the benefit of the Lenders (in such capacities, together with its successors and assigns, “Administrative Agent”) in favor of **ADP DISTRIBUTORS USA, INC.**, a California corporation with an address at 318 S. Dobson Road, Unit 101, Mesa AZ 85202 (the “Grantor”).

WITNESSETH:

WHEREAS, the Grantor entered into a certain trademark security agreement dated July 31, 2020 (the “Trademark Security Agreement”) with Administrative Agent, notice of which was recorded on August 3, 2020 at the United States Patent and Trademark Office at Reel 7013, Frame 0717.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Grantor granted the Administrative Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in all of such Grantor’s right, title and interest in and to the Trademark Collateral, including without limitation the Trademarks listed in **Schedule A**.

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the lenders in association with the Security Interest, (i) hereby releases, terminates and discharges (in each case, without any recourse to, or any representation or warranty by, the Administrative Agent) any and all of its interest in the Trademark Collateral of the Grantor, including all of the goodwill of such Grantor’s business symbolized by the Trademarks and associated therewith, (ii) terminates the Trademark Security Agreement and (iii) if and to the extent the Administrative Agent has acquired any right, title or interest in, to or under the Trademark Collateral, re-assigns to the Grantor any right, title and interest it or they have in, to and under the Trademark Collateral, in the case of each of clauses (i) through (iii), without any recourse to, or any representation or warranty by, the Administrative Agent.

This Release shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.
