The undersigned certifies that:

FIRST: The name and state of formation of each of the constituent entities participating in the merger herein certified (the "Merger") are as follows:

- (a) Groundspeed Analytics, Inc. a Delaware corporation ("Groundspeed"); and
- (b) Two Sigma Insurance Quantified, LP, a Delaware limited partnership (the "Two Sigma").

SECOND: An Agreement and Plan of Merger (the "Merger Agreement") dated as of the date hereof by and among Groundspeed and Two Sigma has been approved, adopted, certified executed and acknowledge by each of Two Sigma and Groundspeed in accordance with the provisions of Section 17-211 of the Delaware Limited Partnership Act and the provisions of Title 8, Section 263 (c), of the Delaware General Corporation Law.

THIRD: Pursuant to the terms of the Merger Agreement, Groundspeed will merge with and into the Two Sigma. Following the Merger, Two Sigma will continue as the surviving limited partnership (the "Surviving Company") and the separate corporate existence of Groundspeed will cease.

FOURTH: The Surviving Company in the Merger is Two Sigma Insurance Quantified, LP, a Delaware limited partnership.

FIFTH: The executed Merger Agreement is on file at the place of business of the Surviving Company located at 201 Nickels Arcade, Suite 201, Ann Arbor, MI 48104.

SIXTH: The certificate of limited partnership of Two Sigma Insurance Quantified, LP as in effect immediately prior to the Merger shall be the certificate of limited partnership for the surviving business entity.

SEVENTH: A copy of the Merger Agreement will be furnished by the Surviving Company, on request and without cost. Any shareholder of the merging corporation, or any partner of the Limited Partnership.


EIGHTH: The Merger shall become effective on December 31, 2023.
