TRADEMARK ASSIGNMENT AGREEMENT

This Agreement (“Agreement”) is entered into by and between Replagic, Inc., a Delaware corporation (“Assignor”) and GoVyr1, Inc., a Delaware corporation (“Assignee”), and is made with respect to the following recitals and is made effective November 29, 2023.

- A. Assignor has used the marks in Attachment A as trademarks and has thereby obtained goodwill in the marks (the “Assignor Trademarks”).
- B. Assignor has obtained the U.S. and foreign Trademark Registrations in Attachment A (the “Assignor Registrations”).
- C. Assignee has become the successor of the ongoing and existing business or portion thereof of Assignor related to the Assignor Trademarks.

In consideration of the premises, mutual covenants and agreements contained in this Agreement, the parties agree as follows:

- 1. Assignor hereby sells, assigns and transfers to Assignee all of Assignor’s right, title and interest in and to the Assignor Trademarks throughout the world in any typeface, stylization, colors, and/or capitalization, and any U.S. state, federal or foreign applications and registrations of the foregoing, including the Assignor Registrations, including the goodwill associated therewith (altogether, “the Assignor Trademark Rights”).
- 2. Assignor agrees to undertake any reasonable efforts, to sign or otherwise complete any documents or steps necessary, to complete the process of perfecting transfer of the Assignor Registrations and the Assignor Trademark Rights from Assignor to Assignee.
- 3. Assignor acknowledges receipt of adequate consideration.
- 4. The validity, construction, and performance of this Agreement shall be governed by the laws of the State of California without regard to principles of conflicts of law.
- 5. The parties hereto are separate and independent legal entities. Nothing herein contained will be construed or deemed hereby to create a principal/agent relationship between the parties nor any form of partnership or joint venture.
- 6. This Agreement may be executed in two or more counterparts each of which shall be deemed an original but both of which together shall constitute one and the same instrument.
