**TRADEMARK ASSIGNMENT**

Effective on the date on which Assignee fully satisfies all of its payment obligations under the Settlement Agreement ("**Assignment Effective Date**"), for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby irrevocably conveys, transfers, and assigns to Assignee, all of Assignor's right, title, and interest in and to: (1) the Registered Mark, and all issuances, extensions, and renewals thereof, together with the goodwill of the business connected with the use of, and symbolized by, the Registered Mark; (2) all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world; and (3) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

Assignor hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office and any applicable jurisdictions within or outside of the United States to record and register this Trademark Assignment. Following the date hereof, Assignor shall take such steps and actions, including the filing for recordation of this Trademark Assignment, and such other actions may be necessary to effect, evidence, or perfect the assignment of the Registered Mark, or any assignee or successor thereto.
