TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (hereinafter "Agreement") is made and entered into as of the 10th day of January 2024 (the "Effective Date") between OneSource Regulatory, LLC ("OneSource") and ProPharma Group Holdings, LLC (hereinafter "ProPharma"). OneSource and ProPharma may be referred to in this Agreement individually as a "Party," or referred to collectively as the "Parties."

RECITALS

WHEREAS, OneSource owns common law trademark rights in QUARRIUS BY OSR for the goods and services shown in Exhibit A and owns the U.S. Trademark Application (Serial No. 97490372) for QUARRIUS BY OSR (filed on an intent-to-use basis).

WHEREAS, OneSource wishes to assign its trademark rights in the QUARRIUS BY OSR trademark to ProPharma;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. OneSource Transfer of Assets

ProPharma has succeeded to the business interests, assets, and appurtenant goodwill of OneSource, and OneSource hereby irrevocably sells, assigns, transfers, and conveys to ProPharma, and ProPharma hereby accepts, all of OneSource's right, title, and interest in and to the QUARRIUS BY OSR trademark, together with the goodwill associated therewith and symbolized thereby, including:

- i. all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof/accruing on or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, violation, breach, or default; and
- ii. all other rights, privileges, and protections of any kind whatsoever of OneSource accruing under any of the foregoing provided by any applicable law, treaty, or other international convention throughout the world.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, OneSource hereby assigns to ProPharma, all right, title, and interest in and to the above-noted trademark and trademark registration application therefor, together with the goodwill of the business symbolized by the trademark and the associated application/registration.
